PROCLAMATION

In 200 B.C. Ecclesiastes wrote, "There is no new thing under the sun." Each year since the founding of Delta Zeta in 1902, the National president has been writing a Founders' Day proclamation. Surely in 1955 there is nothing new to be said. In the years since 1902, the world has seen great changes, times of war, times of peace and prosperity, other times of hardship and want. The peoples of the world have come closer together through man's ability to conquer the water, the land and the air. Living conditions have changed and, in the United States, at least, greater economic prosperity is now evidenced than has ever been known before. Our homes have within them greater comforts than could have been dreamed of at the turn of the century. Our lives have been lengthened through the study of medicine and the consecrated service of those men and women dedicated to the preserving of human life rather than the taking of it. We are told now that we stand on the threshold of a new era when the face of the world may be completely changed by the use of atomic energy either for war or for peace.

But in all this change we know there is nothing new. The basic elements were always there waiting for the genius of man to put them to use. The expression of friendship may have changed somewhat but the basic relationship and man's need for friendship remains the same as it was many thousands of years before Delta Zeta was born. To be able to cling to this great fundamental of life through our close relationship in an organization dedicated to the strengthening and enlarging of friendship should fill us all with a great sense of gratitude.

On this birthday of Delta Zeta, then, let us all highly resolve to re-dedicate ourselves to the cause of friendship realizing that such a re-dedication means renewed service to our sorority, and through it greater service to the world.

Delta Zeta is truly an Adventure in Friendship.

Delta Zeta Establishes National Citizenship Award

"The Gertrude Houk Fariss Award, established in her name as a tribute to the many years of untiring effort and devoted service to Delta Zeta as National President and in numerous other positions, shall be presented to a college chapter of Delta Zeta in recognition of outstanding citizenship."

THUS, Delta Zeta pays tribute to Gertrude Fariss with one of the most outstanding awards ever established by the sorority. Designed to develop community awareness and civic participation, the new Delta Zeta award seeks to point up to the college members their responsibility as citizens and as future leaders in any community of which they become a part. The purpose of this award is consistent with the national program of Panhellenic in which good citizenship among all sorority members is being stressed.

Each college chapter of Delta Zeta will, on its own initiative, select and carry out a worthwhile campus or community service project or projects which may extend over a two year period. The award will be presented at each biennial convention of the sorority and a winning chapter will be announced for the first time at the Delta Zeta National Convention at Miami Beach, Florida, next July.

Mrs. Fariss has, herself, been an example to her sorority in good citizenship. She has filled many positions of leadership in Delta Zeta and other major national organizations. Known for her brilliant mind and progressive ideas, she has been a constant source of inspiration to all Delta Zetas. She is currently serving on the National Council as Panhellenic Delegate. She is a past National President as well as National Secretary, and editor of the Delta Zeta LAMP.

Another major interest of Mrs. Fariss is the American Association of University Women which she has served in many capacities. At present she is a member of the National Board of this organization as National Chairman of the Status of Women Committee. She has been president of the Portland Branch, past State Legislative Chairman, and past president of the Oregon State Division. The Oregon Division honored her by giving a grant in her name in 1953 in appreciation of her leadership.

In Altrusa International she is a member of the International committee on Altrusa Information. She has been president of the Portland club and past Governor of a district comprising five states. In 1952, at the Theta Sigma Phi

She was a member of the accrediting commission for higher schools of the Northwest Association of Secondary and Higher Schools. A member of Omega chapter, Gertrude Fariss received her B.A. degree at the University of Oregon, her M.A. at Cornell, and did graduate work at the University of California.

GML Award Winner Announced

JOAN PETRUNICK, Beta Rho, Michigan State University, has been presented the Grace Mason Lundy Award for 1955. Members of the Honor Court are Connie Sunde, Psi, Franklin College; Anne Clark, Theta, Ohio State University; Marilee Ann Mercer, Delta, DePauw University; Jacqueline Waller, Beta Xi, Alabama Polytechnic Institute; Ann Dodd, Gamma Iota, Memphis State College; Judith Bliss, Beta Alpha, University of Rhode Island; Joan Johnson, Beta Tau, Nebraska Wesleyan University; and Louise Ruch Webber, Gamma Iota, Memphis State College.

Desiring to honor Grace Mason Lundy, E, past national president, for her many years of loyal service to Delta Zeta, the 1946 convention established an award bearing her name, which is given to the most outstanding upperclasswoman from the college chapters. These factors are considered in making the award: service to Delta Zeta and attitude toward the sorority, scholarship, activities and honors on campus, and high ideals and good character.

Joan, a member of the 1954 Florence Hood Award Honor Court, has served her chapter as Sorority Sing Director, song chairman, rush party chairman, and Delta Zeta as Convention song director. Majoring in music therapy, she interns at the Topeka State Hospital. Her campus activities include: Mortar Board (president), Delta Omicron (president), Tau Sigma (scholastic), first Senior of the Week, Senior of the Year, Tower Guard (service honorary), Spartan Round Table, exhibition folk dancing, Jackson, Saginaw and Lansing symphony orchestras, president and vice president of the Music department, orchestra, M.S.U. Trio, Lantern Night chairman, dorm activities, senior ball committee and the '55 Club (Alumni Nucleus Club). On the Dean's List, Joan received a \$500 Mu Phi Epsilon award, merit award, Detroit Delta Zeta Alumnæ award, and tuition and M.S.U. scholarships. She has maintained an all-college scholastic average of B+.

Connie, also a member of last year's Florence Hood Honor Court, is a journalism major. Service to her chapter includes vice president and pledge trainer, publicity chairman, and assistant treasurer. Her campus activities are Theta Sigma Phi (vice president), Senior Class vice president, general chairman of Religious Emphasis Week, Gold Quill (president), *Almanack* (yearbook) business manager, chairman of Matrix Table, May Day, Crippled Children Drive, Modern Language Club program, and Youth Group Visita-

tions; Economics Club, W.R.A., Theta Alpha Phi, Young Republicans Club, Wigs and Cues, Junior Prom committee, and Laurels (sophomore honorary). Connie was Kee Ko Nut Queen and a member of the May Day Queen's court. She has been awarded Delta Delta Delta (twice), state Panhellenic and Pulliam scholarships. In addition to maintaining a strong B average, she has worked as a full-time waitress in her dormitory for four years.

Anne, a home economics major, spent this past summer in Ireland as a member of the International Farm Youth Exchange program. In her chapter she has been publicity chairman, Panhellenic delegate, and president. Her campus activities have included Mortar Board, *Ag Student* Board of Control, Home Economics Club (president, 2 years), university chorus, 4-H Club, Chimes (junior honorary), Mirrors (sophomore honorary), Phi Upsilon Omicron (home economics honorary) vice president 2 years, May Week committees, home economics editor of *Ag Student*, and Panhellenic Workshop chairman. Anne received the Danforth Award for the outstanding freshman in home economics and has maintained a B+ scholastic average.

Marilee has served her chapter as president, assistant pledge trainer, junior and senior Panhellenic delegate and on scholarship and personnel committees. An elementary education major, her campus activities include Mortar Board, Phi Beta Kappa, associate editor of *Mirage* (yearbook), Panhellenic, A.W.S., Y.W.C.A., W.R.A., Greater DePauw Program team captain, WGRE (radio station), Alpha Lambda Delta, and Westminster Fellowship. Her scholastic average is B+.

Jacqueline has been vice president and rush chairman, publicity chairman, and pledge class secretary of her chapter. Her campus activities include Sphinx (secretary), Owls, Freshman Advisory Council, Omicron Nu, Miss Hey-Day 1954, Miss State Day for Alabama, Home Economics Club, W.S.G.A. (secretary and vice president), *Glomerata*, *Plainsman*, and *Auburn Engineer* publications staffs, Baptist Student Union, committees for Village Fair and Religious Emphasis Week. A winner of Danforth Awards in her freshman and junior years, she has a B scholastic average.

Ann is the fifth member of her family to become a Delta Zeta. For her chapter she has been president, historian and scholarship chairman. On campus she was elected Miss Memphis State, to the Hall of Fame, *Who's Who in American*

Colleges and Universities, the Elections Commission, honorary chairman of Delta Zeta Follies, and chairman of the Girls' All Sing. She has also been active in the Student Government Council, Panhellenic Council, Memphis State Education orchestra (concert mistress), string quartet, American Chemical Society (student affiliate), junior class executive council, school religious committee (chairman), BSU evangelistic team (chairman), Panhellenic Workshop (group leader), Presidents' Leadership Conference (assembly leader), German Club and Chemistry Club. In the courts of Junior Miss and Miss Fabulous, she has maintained a B average.

Judith, another home economics major, has been president, music chairman, librarian and intersorority sing leader for her chapter. Her campus activities include Home Economics president, Judicial Board, University Chorus (vice president), Christian Association, W.S.G.A. Council, Sachems (honorary) secretary, Slide Rule Strut Queen, Junior Prom Queen court, Miss URI court of honor, graduation marshal and the yearbook staff. Elected to *Who's Who in American Colleges and Universities*, she has maintained a B average.

Joan has served her chapter as second vice president and rush chairman, delegate to national convention and in various other chairmanship

positions. On campus she was a member of Phi Kappa Phi, Cardinal Key (secretary), Yellers of Brown (vice president), Future Teachers of America (president), Art Department (student secretary), Y.W.C.A., Opera chorus, Association for Childhood Education, Wesley Fellowship, and the Plainsman Players. On the honor roll, she was also a library student assistant, chosen as one of Wesleyan's five representatives for Nebraska Celebrities dinner honoring future teachers, and received a gold star rating on a weaving exhibition. Her scholastic average is B+.

Louise, or "Ruchie" as her chapter knows her, has been pledge class officer, song leader, publicity chairman, corresponding secretary, first vice president and is now president of her chapter. A voice major, she has had solo roles in several campus productions. Other activities include Tassel (treasurer), *Tiger Rag* staff, Liberal Arts Honorary (Φ B K equivalent), Modern Dance Club (president), Newman Club, College Choir (secretary), College Social Committee, Lambda Delta (freshman honorary) secretary, Pi Kappa Alpha Dream Girl, Pi Kappa Alpha Sweethearts Club (president), *DeSoto* (annual) Favorite, Homecoming Queen alternate, and Miss Fabulous Court. A recipient of the Coterie Club scholarship, she maintains an A— average.

Scholarship Winner Announced

THE 1955 winner of the Arlene Davis Aviation Scholarship is Joan Cardon, Alpha Gamma, a junior at the University of Alabama.

Joan showed an interest in aviation when she was still in high school. She persuaded her Girl Scout leader, who had done a great deal of flying and aviation work to start a Wing Scout Troop in Birmingham. After the formation of this group, Joan served as pilot. They studied flying principles, took actual flights, and even cleaned airplanes to pay for the flights. The group also made movies of flying incidents and Joan gave lectures about them to parents and other interested persons.

While in Birmingham she became a member of Flight I of the local Civil Air Patrol, leaving only to attend school. At the university she has done more intensive study, although her "flights" have recently been limited to reading and flying when finances permit.

Joan has served Alpha Gamma chapter as historian, treasurer and house manager. She is also a member of Triangle (honorary), Agnes Allen Harris Club and the Women's Spirit Committee.

The Arlene Davis Aviation Scholarship is awarded annually to a sophomore or junior girl who is interested in choosing aviation as her career. The award is made possible by Arlene Davis, famed aviation enthusiast who has logged

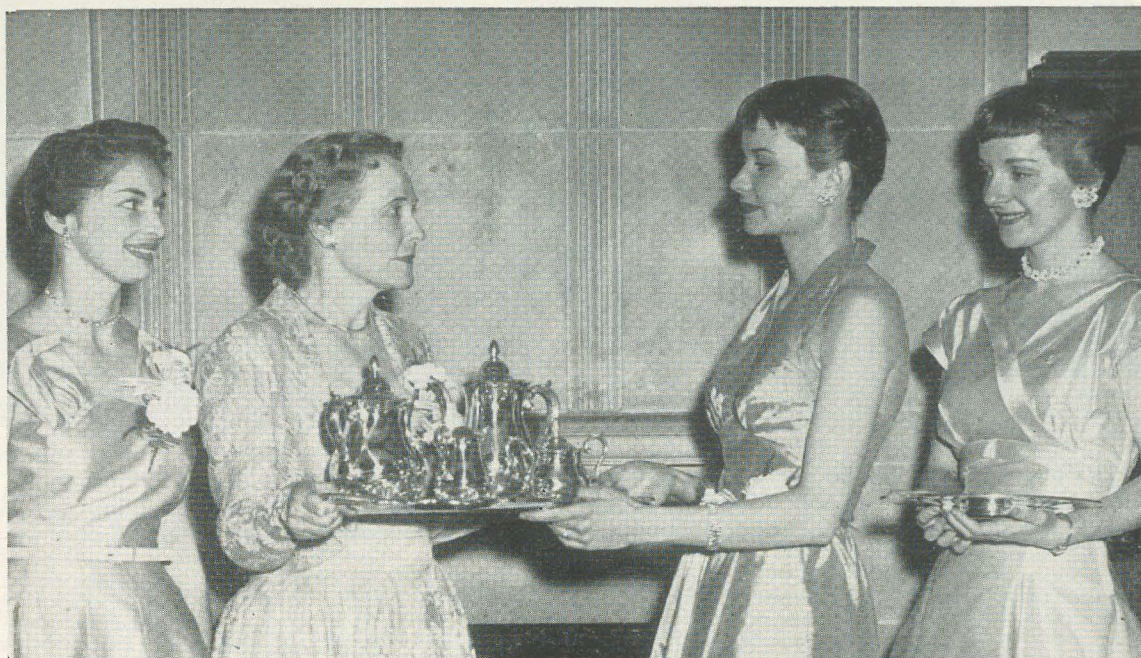

Delta Zeta Magic

LETTERS to the editor frequently prove to be most interesting reading. However, this one, printed below, brought an extra-special bonanza to be shared with all Delta Zetas.

"Delta Zeta was, indeed, the envy of sororities throughout all of Ohio when the enclosed cartoon appeared on the editorial pages of *The Cleveland Plain Dealer* on June 2, 1955. Doubly proud were our own Gamma Alpha girls, for the cartoonist, Edward D. Kuekes, (pronounced Key-kess) is the husband of Clara Gray Kuekes, a patroness of our chapter at Baldwin-Wallace College, of which both are alumni.

"Ed Kuekes, undoubtedly Cleveland's most renowned newspaperman, needs no introduction to journalists anywhere in the United States. The recipient of countless accolades for outstanding journalism—including the 1955 National Freedom Award, the 1954 Christopher Literary Award, and the 1954 Brotherhood Award of the National Conference of Christians and Jews—Mr. Kuekes won the Pulitzer Prize for the outstanding editorial cartoon published in an American newspaper in 1953. His enclosed letter attests far more eloquently than could I to the charm of the man and to the place which Delta Zeta has won in his heart.

"Upon viewing his cartoon in the *Plain Dealer* (which is, unquestionably, the 'prestige' newspaper of the nation's Seventh City with the largest state-wide circulation in northern Ohio) I was seized with the idea of securing a copy for the LAMP. Instead, Mr. Kuekes graciously offered to loan us the photoengraving itself. . . .

Mr. Kuekes' letter follows:

"When Mrs. Kuekes consented to be a sponsor of the Delta Zeta Sorority at Baldwin Wallace College, Berea, Ohio, I did not know it at the time, but apparently with her honor I automatically became her deputy chauffeur.

"In that capacity Mrs. Kuekes and I attended a Δ Z picnic supper. The occasion being the completion of the May Day float.

"My first impression of the girls was startling. Dressed in their jeans and care-free hair-do's they did not present a picture that would attract a Hollywood scout.

"I sensed immediately however, that they had spirit, a wonderful spirit of good-fellowship.

"The May Day became history and we were invited to attend the annual prom.

"Never, no never, have I ever witnessed a more beautiful transformation.

"Gone were the faded jeans and pony-tail hair styles and in their places were the most beautiful and gracious gals in the world—and that was when the cartoon idea was born.

"Do we love the Δ Z girls—you bet your life we do.

Delta Zeta Musician Wins Honor

WHEN the new edition of *Who's Who in the West* appears, it will include the name of Mu chapter's Virginia Ballaseyus. The list of achievements is an impressive one: writer of radio and TV scripts, member of Composers Forum and ASCAP, and a long list of musical publications. Few women achieve the honor in ASCAP. (One reason is that women are supposed to create and not invent; the other, that ASCAP membership entails the demonstrated ability to create and publish successful music—it applies the test of public acceptance.)

Virginia's scope of musical writing is a wide one: from the simple little song of *Mother Goose*

on *Parade*, which brings royalties from all over the world, and *California*, the hit tune of three recent California Centennial Productions and now on the front line for the theme song of the 1956 San Francisco Republican convention to piano scores, popular tunes, ballet music, and a three act Musical Production. Good taste in music is her only concern; be it popular, semi-classic, or longhair.

For those who lean toward numerology, there may be a connection of philosophies for those born on the same day. Virginia shares, inadvertently, one of the precepts of the late Albert Einstein, "Try not to be a person of success; but rather try to be some one of value. A person is considered successful in our day who gets more out of life than is put into it. A person of value will give more than is received."

To Virginia, immediate success long has been cured of any illusions. Her greatest labor has been on music that has been rejected. Contrary to popular belief, the writing of music is not turning on a little faucet; it is not the result of little or no technique, plus abused artificial themes. Nor is it a confused, intricate, mechanical elaboration or analysis, which has no beginning, middle or end. For perfection in any art means restraint; it means hard work; it means a constant striving to maintain artistic pride and craftsmanship, with ideals that are clear and a conviction that is firm. It should be a work that speaks for itself; something that is put forth with joy and life and devotion from the heart and from the brain. To write anything, simply and beautifully, is a difficult thing. Music, like other true values, cannot be manufactured on the assembly line; it has something to do with the mysterious essence of man—the whole and only reason for existing.

Those who have heard her composition, *The Song of the River*, know that this is what Virginia believes.

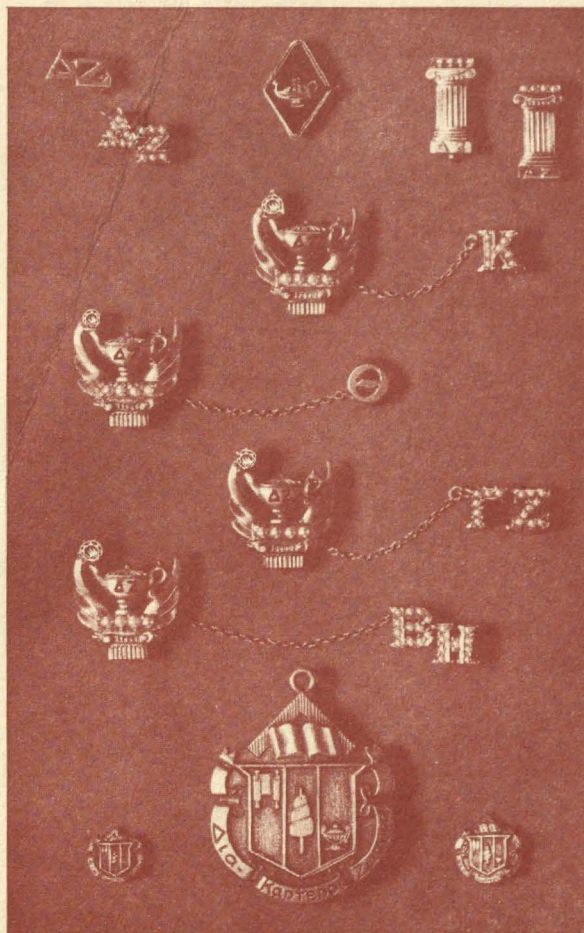
