Memorial Plaque and Scholarship Presented to Miami University at **Golden Anniversary Dedication**

THE last business session of our Golden Jubilee Convention in New Orleans, it was voted to place a Memorial Plaque at Miami University on the fiftieth anniversary of Delta Zeta's founding and National Council was given authority to appoint a committee to study

and plan for this project.

Mrs. Rudolf O. Cooks, national constitution chairman, former national extension vice-president and member of the Board of Trustees at Miami University was asked to serve as chairman of this special committee and the following members were named to assist her: Mrs. Crawford Nixon and Mrs. Robert Randolph, former directors of Province V: Mrs. Fred Joyner, former alumnæ advisor to Alpha chapter for many years; Nancy Hefner, president of Alpha chapter and Mrs. Hubert M. Lundy, National Historian and former national president.

Since Alpha chapter had extended an invitation to all Alpha alumnæ to return to the campus for a fiftieth birthday celebration before this special committee began functioning, plans were made to coordinate the anniversary celebration and the dedication of the plaque on Saturday, October 25. Letters heralding the event were sent to college and alumnæ chapters within an approximate two

hundred mile radius of Oxford.

Delta Zetas journeved from Indianapolis, Cincinnati, Dayton, Columbus, Cleveland, Berea, Hamilton and surrounding towns to be present for the gala occasion and to be with our Founders, including three former national presidents of Delta Zeta, Mrs. John W. Pease, Mrs. Hubert M. Lundy and Miss Irene Boughton; the director of Province V (South), Miss Lois Westerman and the regional alumnæ director of I, Mrs. Robert A. Beach. Arlene Davis, famous woman aviatrix, who was recently initiated into Delta Zeta at Baldwin-Wallace College, was present for the festivities, accompanied by a cavalcade of cars filled with Gamma Alpha girls.

The dedication ceremony was held in Hamilton Hall at two thirty o'clock Saturday afternoon. The bronze plaque measuring approximately eighteen by twenty-two inches, was placed on a large wooden easel at one corner of the lounge and was covered by the beautiful new rose and green satin flag of Delta Zeta. Centered in the upper half of the plaque is the crest and on either side, the dates 1902 and 1952. Below the crest

GOLDEN ANNIVERSARY DEDICATION 1952

A greeting was given by Lucile Crowell Cooks before she introduced Paul F. Erwin, director of Religious Activities at Miami University, who gave the invocation. Following the formal presentation of the plaque, Mrs. Cooks presented a check on behalf of the National Council of Delta Zeta and as a further tribute to our Founders, for a scholarship which will provide a year's tuition to a deserving woman student. Dr. C. W. Kreger, vice-president of the University accepted the plaque and scholarship with grateful acknowledgment. The permanent location of the plaque is near the south entrance of Harrison Hall "Old Main" in the main corridor near the former office of Dr. Guy Potter Benton who was the president of Miami University at the time of the founding of Delta Zeta.

At the conclusion of the dedication, the Oxford alumnæ were hostesses for a tea honoring our Founders, Julia Bishop Coleman and Mary Collins Galbraith. To the great disappointment of all of us, Alfa Lloyd Hayes was unable to be with us because of an accident which sent her to the hospital with a seriously injured knee shortly before she planned to leave for Oxford. Invitations to the tea were sent to administrative officials of the University, faculty friends, alumni advisors and presidents of all sororities and fraternities on the campus and other guests. Mrs. Herbert Wiepking was chairman for the tea, assisted by Mrs. Richard Young, Mrs. William Suhring, Mrs. Stuart Fitton, Mrs. Albert Wald, Mrs. A. J. Alton and Mrs. Joel Wiant.

The Golden Harvest was the theme for the banquet given in Oxford College Hall Saturday evening, for which the members of Alpha chapter made the arrangements. Over two hundred Delta Zetas gathered together for this memorable Founders' banquet to hear the inspirational messages of the speakers—Mary Collins Galbraith, Julia Bishop Coleman, Grace Mason Lundy, Irene Boughton and Arlene Davis. Nancy Hefner, president of Alpha chapter, presided and introduced the guests of honor. A message was read from Miss Elizabeth Hamilton, former dean of women at Miami University for forty years, whose illness prevented her from being present.

Those of us who were privileged to have a part and be present for this Golden Anniversary Dedication, will long treasure this Golden Day in a corner of our hearts as a Golden Delta Zeta

Memory.
