



### OUNDERS DELTA ZETA



In 1971, Grace Mason Lundy (1893-1993), Past National President and Past Historian, published a booklet for collegians entitled "The Founders of Delta Zeta." As Delta Zeta begins the Centennial Year. we will publish excerpts from that booklet in upcoming LAMP issues. In each set of excerpts, various sections of the booklet will be tied together with a common thread. In this excerpt, we look at Mabelle May Minton (1880-1929).

### Introduction

They founded a sorority for us. They became alumnae. What did they do in the years after they left Miami? Most kept in close touch with the sorority they established with so much love and high ambition. But what DID they do, where did they live, and what do we know about their later lives?

This question came up once from a Delta Zeta who wanted to know these things for a talk she was planning on a Founders' Day. To help her, and perhaps many others of you, I have written this little booklet which tells most of what we know, and only shows us how much more we wish we could know, now that all our Founders live only in memories and grateful hearts.

# Mabelle May Minton



Mabelle Minton was the oldest child in a family of eight, another family growing from a college romance, but in this case the parents, Florence Parker and Harvey Minton, had met as students at Wheaton College in Illinois. The family was living in Ohio, at Buena Vista Farm near Hamilton, when Mabelle was born, and she graduated from Hamilton High School. College began for her also, at

Wheaton, but Miami University, nearer home, drew her in 1902, and she was active in the new sorority during its first year.



GRACE MASON LUNDY

In 1903 the death of her mother kept her home as head of the household, and it was two years before she could resume her collegiate life, this time at Teacher's College of Columbia University. A short teaching period in the East ended with a decision to go into business, and she chose the actuarial field.

In the early years of Delta Zeta growth she had contributed a great deal to its extension, this being a field of special interest to her. She was the organizer of Iota, Omicron, and Xi Chapters. It was due to hopes for a chapter at Minnesota that the chapter name of Gamma was reserved for a chapter there, even though it did not become a reality until 1923. She was of special inspiration at Conventions, and her attendance at the 1910, 1912 and 1914 Conventions was a highlight for all collegiates who met her.

# The Articles of Incorporation


Mabelle Minton's sister, Lillian Minton Krebs was an early initiate in Alpha and has all her life been a steadfast, lovely Delta Zeta. Some of you have met her at the conventions she has attended; you may recall her as the hostess at Miami in the 1964 post-Convention tour there. To her we owe the discovery of the long-lost original charter to Delta Zeta from the State of Ohio.

### Addenda

The original document, in some of Alpha Chapter's moves, later was misplaced and mourned as lost. A diligent search by Lillian Minton Krebs discovered it after many years, in some long-undisturbed boxes of sorority mementos.

# Accepting the Challenge of Leadership

The Norma Minch Andrisek Leadership Conference for 2001 set new attendance records with over 460 delegates as it began on the evening of June 29, 2001. At Purdue University in West Lafayette, Indiana, collegiate officers eagerly awaited the opening remarks from National President Karly Burns as the lights dimmed, voices stilled, and the program began.

Mrs. Burns introduced Norma Minch Andrisek, Past National President and the conference's namesake, saying, "This conference is named in honor of Mrs. Andrisek and the leadership she has given Delta Zeta over the years." Mrs. Andrisek then reminded the audience that "The name of the conference is not important—the word that is important is 'leadership.' Each and every one of you is a Delta Zetas leader, and when you leave this conference, you will be taking something very special with you."





# A Greek System for the Future

The program then kicked into high gear as David L. Westol, Executive Director of Theta Chi National Fraternity, took the stage to give the keynote address. David has lectured on legal affairs and liabilities at over 200 campuses and fraternity conventions. He gave a compelling presentation entitled "Hazing on Trial." Using a mock trial setting, he played the part of a prosecuting attorney crossexamining a Delta Zeta college chapter president during an investigation into the accidental death of a collegian at a party hosted by the chapter and a fraternity.

David's re-enactment made a sobering statement to the audience and brought home the point of taking responsibility for risk management issues—and taking the precautions to ensure they don't happen. "If we don't do something [as Greeks], the Greek system won't be around all that much longer. The idea is very simple—we've got to take a stand.

Everyone can have parties. Only a few people have the vision and ideals to believe in something bigger than themselves. We want to have a Greek system for our sons and daughters to come to."

Saturday, June 30 kept delegates busy as they attended breakout sessions, lectures, and workshops. Collegiate officers were excited about actual hands-on workshops in the areas of their interest. There were many breakout sessions to choose from, including "Five Simple Steps to Recruitment," "Making Academics a Priority," "Productive Partnerships: Working with Greek Advisors and Panhellenic Council," "A Sorority of Substance, Not About It," "Values Based Leadership," "The 100% Involvement—How to Make it Happen," "Alumnae Involvement," "Communication-It Shouldn't be So Difficult," and "Selling the Delta Zeta Product."

# The National President's Collegiate Advisory Board— Leading the Path to Excellence

The National President's Collegiate Advisory Board met for the first time at the NMA Leadership Conference. The members of the Advisory Board are the college Chapter Presidents of Crest Award-winning chapters for the past biennium. The Crest Award is presented at National Convention to outstanding collegiate chapters that have excelled consistently in all areas of college programming.

The Board's purpose is to provide information to the National Council and/or its representatives regarding the college chapter or individual collegian's perspective and needs relevant to college programs, issues, behaviors, or other areas as determined by National Council. This dialogue will not only benefit current chapter members, but will serve to improve the chapter as a whole.

# Katie Sermersheim Honored by Phi Kappa Tau Fraternity



Katie Sermersheim, Secretary of Delta Zeta Sorority's National Council and member of the Training Committee, was presented with a special honor from Phi Kappa Tau Fraternity—the Interfraternity Educational Fellowship.

Phi Kappa Tau implemented the Fellowship in 1997 to recognize and reward outstanding individuals who contribute to their fraternities and the entire Greek community. Katie is a doctoral candidate in Educational Administration at Southern Illinois University and is the Assistant Director of Student Development at the university as well, and has many credentials in the Greek and academic realms.

William Jenkins, Executive Vice President of the Phi Kappa Tau Foundation and current President of the North-American Interfraternity Conference (NIC), awarded the fellowship to Katie. Citing one of Katie's colleagues at SIU, Dr. Nancy Hunter Pei, Director of Student Development, he quoted, "'Katie has been instrumental in providing direction for our Greek community. Because of her careful guidance and professional diligence, she has earned the respect and admiration of the students, Greek alumni, faculty and staff as well as her professional colleagues throughout the country."

When asked how being a Greek has enhanced her life, Katie said, "Delta Zeta has laid the foundation for who I am today. Without Delta Zeta, I would never have sought a master's degree or would never have worked on a college campus as a Greek advisor. Delta Zeta has given me experiences I would never give up or change about my life. Delta Zeta has taught me temperance, insight, and courage, and provided me with opportunities for personal, professional, and academic growth."

# **Exciting Programs and Presentations**

The keynote speaker for Saturday was Ginny Carroll, a former Executive Director of Alpha Xi Delta. She discussed the importance of ethics in our lives, and how those ethics are an inherent part of the values that Greeks live each day.

A special donation of toys and money, collected from each chapter attending the conference, was presented to the Department of Audiology and Speech Sciences of Purdue University. Mary Lou Miller, Speech Language Pathologist, said, "I would like to thank you for your generosity and support. Your donations are greatly appreciated and will enable us to better serve children in our clinic. Your commitment to your sorority and to helping others is heartwarming. Thank you for honoring our clinic with your philanthropic spirit."

# 2001 Leadership Conference



Members of Delta Zeta's Centennial Committee were introduced to unveil plans for the coming Centennial Year. Norma Minch Andrisek, Chairman of the Centennial Committee, said, "Our Founders are responsible for our knowing one another. They have provided, for almost one hundred years, their insight and courage, and the forum by which we do know one another. I feel very indebted to them, and I know you do, too."

Many of the collegiate delegates enjoyed the roundtable discussions that were held on Saturday evening. The collegians had the opportunity to break into groups by officer title, and then later by specific topics of interest, to share ideas and discuss similar challenges they encounter in their chapters. Everyone agreed that the evening provided valuable information and insight into the responsibilities chapter officers share in guiding their chapters.

The NMA Leadership Conference concluded on Sunday morning with a closing activity that allowed attendees to share their thoughts and feelings about those who had come to mean the most to them-whether it was someone they had known for a while in Delta Zeta, or someone they had met that weekend.

Delta Omega Chapter President Michelle Joy summed up the feelings of the delegates as she said, "I felt so special to be a part of an organization of thousands of women just like me who come together to create something so important. I believe that every chapter, no matter how big or small, is crucial to Delta Zeta in the scope of the national organization. Each individual chapter, each individual girl, makes Delta Zeta what it is today."

# 2001 CCD CONFERENCE

The Delta Zeta CCD Conference was held on July 20-22, 2001 at Purdue University in West Lafavette, Indiana. Delta Zeta College 2001 Chapter Directors (CCDs) CCD Conference and Regional Collegiate Coordinators (RCCs) came from almost all 50 states to spend time training and gaining leadership ability

at the annual conference. The CCD Conference is supported through the contributions to the Delta Zeta Foundation made by chapters, members, and friends of Delta Zeta.

The Stewart Center was a buzz of excitement on Friday evening as the women were welcomed to the conference. The CCDs then disbursed into regional meetings. On Saturday, the assemblage was updated on the latest Centennial Celebration news before going into breakout sessions, which included timely topics such as "CCD 101," "Advising Your Way Through Recruitment," "What is Ritual?" "Delta Zeta Academics-A Step Ahead," and "Officer Training," among others. RCCs also attended





# SHARING THE MISSION



As a member of the university community where Delta Zeta has its chapters, we want to be a part of serving the mission of the institution. We have asked school officials to share with us their thoughts about what Delta Zeta and other Greek organizations can do to make a positive contribution to that end. Associate Vice Chancellor for Student Affairs and Enrollment Management and Dean of Students at Southern Illinois University Dr. Jean Paratore discusses how Greek organizations are part of the campus tradition, and how those organizations enhance the strengths of the schools at which they have chapters.

Please describe your role as Associate Vice Chancellor for Student Affairs and Enrollment Management and Dean of Students of Southern Illinois University/Carbondale.

As my title indicates, my role is really divided into two roles. First, as Associate Vice Chancellor, I serve as staff to the Vice Chancellor for Student Affairs and Enrollment Management. In that role I represent the division on campus-wide committees and task forces and fill in for the Vice Chancellor in his absence. I also work with individuals across departmental and divisional lines in responding to campus emergencies or student crises, preparing SIUC's response to our annual Campus Crime Report, chairing our division-wide staff development committee and other assignments as they arise. I also, upon request, advise the Vice Chancellor on all matters within the purview of our division.

As the Dean of Students, I have line responsibility for eight units within the division: Career Services, Counseling Center, Disability Support Services, Intramural-Recreational Sports, New Students and Family/Parent Programs, Student Development, Student Judicial Affairs, and Students Legal Assistance.

### How many Greek organizations are on the SIU campus?

At present we have 23 organizations recognized on campus. We are planning to expand and could add one or possibly two additional fraternities within the year.

Delta Zeta's Gamma Omega Chapter has been a part of the Southern Illinois campus since 1953. How do you believe Delta Zeta and other Greek organizations contribute to the overall strength of the university?

The women of Delta Zeta are very involved in the student leadership of the campus. They hold leadership positions on Panhellenic Council and the Inter-Greek Council. They serve as Student Resident Advisors in the residence halls and are very active in other large student organizations. Certainly, the wealth of community service activities in which they participate is noteworthy. Delta Zetas can be found throughout the community donating hours of service to such worthy causes as the AIDS Walk, Habitat for Humanity, and the Girl

Scouts of America. The involvement of Delta Zeta and all of our Greek organizations in campus leadership, including student government and in service to the community, is impressive and vital not only to the agencies served but also to the holistic growth and development of the women and men of our Greek organizations.

# Do Greek organizations play a large part of the tradition of the SIUC campus?

During our major weekends such as Saluki Family Weekend and Homecoming, our Greek organizations shine as the students who do the very most to perpetuate our traditions. Without our Greek organizations there would most likely be no Homecoming parade and certainly there would be no King and Queen. They are the spirit of the campus. One of our newest traditions occurs at the very beginning of the Fall semester. Freshman move-in day is a special time for our campus and the Greeks are a major part of our new student welcome. They participate en masse as "Greek Movers," helping our new students move into their residence halls along with our Student Life Advisors, many of whom are also Greek. The emphasis is to be welcoming and helpful and at the same time to promote the Greek experience.

# How do Greek organizations contribute to the quality of campus life for the students?

Our Greek organizations contribute to the quality of campus life in so many ways. They provide leadership for many organizations and contribute in innumerable ways to the community through volunteer service. They also work very hard to improve their academic status. In fact, the all-fraternity grade point average for Spring semester 2001 exceeded the all-men's average. Each chapter house has study hours, especially for the new members. Members help their sisters and brothers when necessary as tutors and emphasize the importance of attending class.

We are also very proud of how our Greek community is working to ensure that social gatherings adhere to the regulations they helped to enact just two years ago.

The Greek Millennium Initiative is a plan designed by the Greek leadership that establishes goals for all our chapters in such areas as academic achievement, community service, safety, and leadership. The plan also includes the system currently in place and is working very effectively whereby the Greeks monitor the social events sponsored by our fraternities. Self-regulation is the central focus of the plan and is working extremely well. They have also established a Greek Judicial Board, comprised entirely of members of our fraternities and sororities. This Board is trained through a class taught by our office of Student Judicial Affairs. The Board hears cases involving violations of the Greek Millennium Initiative and makes recommendations of sanctions to the Greek Advisor. Those on the Board take their responsibility very seriously, as do those who monitor fraternity social events. The leadership demonstrated by members of our Greek community with respect to the monitoring and enforcement of the Greek Millennium Initiative has been outstanding.

Dr. Jean Paratore arrived at SIU Carbondale in 1974 and has held numerous positions throughout her 27-year tenure. Her Bachelor of Science degree was earned at the University of Massachusetts at Amherst in 1971, her Masters of Education from the University of North Carolina at Greensboro in 1974, and her Ph.D. in Education with a Specialization in Higher Education Administration from SIU Carbondale in 1984. Dr. Paratore also serves as an Adjunct Associate Professor with the Department of Educational Administration and Higher Education, teaching within the College Student Personnel program of that department, and serving on numerous doctoral and master's level committees. Dr. Paratore is a member of the American College Personnel Association (ACPA) and has served that Association as its President. In association with the People to People Ambassadors Program, she led a delegation of student affairs professionals to the Peoples Republic of China in May 2000. Dr. Paratore has authored five publications and has given more than twenty professional presentations. She is also a member of NASPA, AAHE, Phi Kappa Phi, and Phi Delta Kappa.

### ABOUT SOUTHERN ILLINOIS UNIVERSITY

Southern Illinois University is a multicampus university comprising two institutions, Southern Illinois University at Carbondale (SIUC) with a School of Medicine at Springfield and a campus in Niigata, Japan, and Southern Illinois University at Edwardsville (SIUE) with a School of Dental Medicine.

The University enrolls over 34,000 students in programs from two-year technical curricula to Ph.D. programs in 27 fields along with law, medicine and dental medicine. 
### MID-ATLANTIC AREA (DE, MD, NJ, PA)




