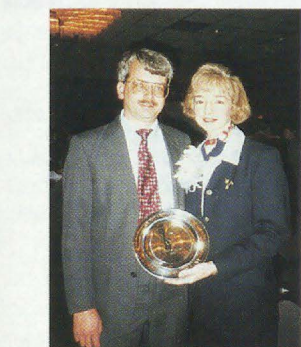

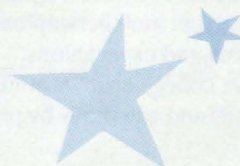

## Delta Zeta's Structure for the Future

# Investment in Leadership Training Expected to Pay Off in People Dividends

*All members of Delta Zeta shall be chosen for moral, social and intellectual worth. Membership shall not be denied because of race, color, religion, national origin or handicap. It shall be the duty of each member to exemplify in her daily conduct the noble principles of this sorority, to promote the welfare of the whole by every means consistent with a high sense of honor, to obey its laws, to avoid all conduct which may be criticized among acquaintances or be offensive to her fellow members, and to exert herself to promote and maintain the harmony and prosperity of the sorority.*

— Article III, Section 3,

*The Constitution of Delta Zeta Sorority*

Perhaps in our rush to succeed, in our every day busy-ness, in our break-neck routine, we forget our way, the reason we are here, the reason we are. Perhaps we've known all along but haven't been able to slow down long enough to do anything about it. Our National Council said "stop!" and we did. We stopped and looked to the future. We stopped and looked to the past. We saw 100 years behind us and we saw many hundreds of years before us, but only if we changed what we were doing. As the saying goes, if you keep doing things the same way you've always done them, you'll keep getting what you've always got.

National Council determined it was time to return to basics — the principles upon which we were founded. These principles, as so eloquently stated in our Constitution, would serve us well as we near our Centennial celebration. Through indepth strategic planning, National Council developed its vision of the future: To instill pride, sense of loyalty and responsibility in every Delta Zeta. So that vision may become a reality, the Council established three major goals for Delta Zeta:

- 1) Train current membership on Delta Zeta standards and expectations;
- 2) Improve college chapter public relations internally and externally by presenting to

all of our publics a positive, focused message of excellence; and

- 3) Improve academic performance and programming.

Delta Zeta envisions a future with well-trained leaders who will guide our sorority into the next millennium. Training must be leadership oriented, rather than procedural training. There are manuals and guidelines already in place which anyone can read and learn procedures. What must be taught is leadership skills.

With Section 3 of Article III of Delta Zeta's Constitution as the basis, a training team was formed and set about planning the training for the leaders of today and tomorrow.

Within this one paragraph of our Constitution lies all the answers to who we are as Delta Zetas. If we follow these noble principles, we cannot help but succeed. The defining principles upon which Delta Zeta would focus its energies are:

- 1) **Values**
- 2) **Leadership**
- 3) **Membership**
- 4) **Academics**
- 5) **Ritual**
- 6) **Challenges and Choices**

These themes were used to develop the training curriculum for both the College Chapter Directors Conference and the Norma Minch Andrisek Leadership Conference for chapter leaders.

At the 1996 National Convention in Palm Springs, delegates first approved the new structure which declared that training our volunteer corps is one of the six major issues our sorority must tackle. And in just little more than one year since that day, Delta Zeta has trained its college chapter leaders, CCDs, Regional Collegiate Coordinators and Area Alumnae Directors.

It is for the chapter president, the CCD and all the other women who volunteer their time for Delta Zeta that such a high priority has been placed on training. With this investment in our people, Delta Zeta knows it will pay off in huge dividends. Though still in its infancy, the training program will prove invaluable to our alumnae and collegiate leaders and will provide a solid foundation for Delta Zeta's future.



# First CCD Conference focuses on Delta Zeta's top volunteers

The new structure approved by the Delta Zeta membership gives the college chapter director (CCD) more authority than ever in guiding the collegians entrusted to her. Always considered the most important link between collegians and alumnae, the CCD is now being asked to perform an even greater role on college campuses across the country. With this new authority and responsibility assigned to the CCD comes the need for Delta Zeta to equip them with the tools they need for their crucial jobs.

For the first time ever, Delta Zeta brought more than 100 CCDs from all corners of the United States to Louisville, Kentucky, for an intensive weekend-long training session.

Cathy Barth Giangarra, CCD of the Beta Gamma Chapter at the University of Louisville, summed up in one sentence the relevance of the training program: "The Delta Zeta CCD Conference was the best thing National Council has ever done for its front-line volunteers."

National Vice President of Collegiate Affairs Karly Klemp Burns and National Panhellenic Delegate Jamie Hammill Pyne opened the training conference with a presentation that began the thinking process of what changes have occurred in the past 25 years and what changes we can expect in the next 25 years. Then Norma Minch Andrisek, past national president, presented "Delta Zetas Past and Present," especially with respect to the college chapter director. They were all quite impressed with the former title for the CCD job - VIP for "Vestal in Power." National President Sandra McAlister Nesbitt explained the overall training theme of "future perfect."

Special guest speaker Maureen Syring, past national president of Delta Gamma Fraternity, gave a dynamic presentation which encompassed many relevant issues

of working with college women and particularly sorority women in today's world. She emphasized that, as advisors, we must care, have conviction and have courage.

Delta Zeta's Executive Director Cynthia Winslow Menges presented "The College Chapter Director — The Position of Choice," stressing the power tools the CCDs have available for their use — our constitution, our ritual, their hearts and their heads. She also stressed the need through role modeling and teachable moments to instill a sense of pride, loyalty and commitment in our college members, as they are the future of our sorority.

One of those teachable moments came when Jamie Pyne reflected on a conversation she had with a collegian at the Norma Andrisek Leadership Conference at Berkeley this summer. "I was talking to her about her position as vice president of programming. She really did not know what she was doing, so I was trying to give her suggestions on how to learn her specific job. When we finished talking, she said, 'Boy, I really need to get on the clue bus.' When we did the CCD training, I

related the story to the CCDs to emphasize chapter officer training. The whole idea just took off. I handed out drivers' licenses to all the CCDs which entitled them to drive the Clue Bus." No doubt, "clue bus" will become a new phrase in the Delta Zeta vernacular!

# College chapter leaders take a step toward Delta Zeta's "Future Perfect"

Not only do college chapters need well-trained alumnae advisors, they need knowledgeable college leaders to guide their organization. The Norma Minch Andrisek Leadership Conferences were developed to provide college officers and soon-to-be leaders with the tools they need to lead their chapters.

Named for then National President Norma Andrisek, the leadership conferences were first held in 1980 with 172 women in attendance. This past summer more than 600 women received training at five college campuses across the country. The Delta Zeta Foundation funded a portion of the leadership conferences which were held at Emory University, Purdue University, University of California at Berkeley, Texas Women's University and the University of Pittsburgh at Johnstown.

The leadership conferences are held every other year in "off-convention" years. Collegians come together at these conferences for a more direct and personalized leadership training experience. The training team is made up of the members of National Council, National Committee Chairmen, Regional Collegiate Coordinators and chapter consultants, as well as local speakers at each conference location who have expertise in various leadership principles.

The theme of the 1997 leadership conferences was "Future Perfect" with a focus on the core values and beliefs upon which Delta Zeta was founded. The conferences included workshops on values, leadership, membership, academics, ritual and risk management.

Leadership conference goals were:

- Participants will be challenged to become values-centered leaders.
- Participants will develop a greater awareness of being role models through words and actions that are consistent with Delta Zeta values.
- Participants will develop an understanding of the urgency for change and their responsibility to facilitate it.
- Participants will leave encouraged, energized and confident to face the challenges ahead.

- Participants will understand how they can take components of the workshops back and teach others in their chapters.
- Participants will understand how to apply Delta Zeta resources to problem-solving and programming on their own campuses. The thinking tools will enable them and their chapters to problem solve more effectively.

For Rachel Doletzky, president of the Gamma Sigma chapter at Eastern Michigan University, the leadership conference was a success. "Our brand new executive board gained some valuable new tools," she said. "We also acquired an aspect of values we could take back to our chapter. We learned a lot and had a lot of fun meeting other sisters from around the country."

Jessica Thaut, corresponding secretary for the Beta Tau chapter at Nebraska Wesleyan University, agreed. "We were very fortunate to meet so many other Delta Zetas and take back with us a better understanding of the values of our sorority."

# At National Headquarters, Delta Zeta is a

All in a day's work, they may talk to hundreds of women. Some who are grandmothers, some in college, some who are volunteer leaders, some who are looking for a magazine they ordered, some who are calling about repairs to their chapter house, some who want to change their address — but all who are Delta Zetas. This is the Delta Zeta National Headquarters, where the day-to-day business of a sorority happens quietly without fanfare.

There are 19 employees at Headquarters, located in Oxford, Ohio. Cynthia Winslow Menges, Alpha, is the sorority's Executive Director and oversees all operations of Delta Zeta. On any given day, 300 phone calls and 200 pieces of mail (the 10th of the month is much bigger!) come into their offices and they send out up to 1,000 pieces of mail each week.

For those of us "out in the field," all we know is that the work gets done. When we ask for a magazine, we get it; when we order a Delta Zeta T-shirt, we get it; when we want information about joining an alumnae chapter, we get it. But to really appreciate all that goes on behind the scenes, let's take a look at a day in the life of the Delta Zeta Headquarters.

**8:00 a.m.** A house director calls Pam Voss to inform her of a necessary house repair. Toni Cox runs the credit cards for the members who are charging their dues. Rosina Boyer does the cash report for the National Housing Corporation and gets things organized for the day. Carla Hamblin is answering phones and retrieving messages off the voice mail system. Diane Young starts her day by organizing her work. Sandy Cox works on the cash report while taking a call from a house mom

regarding receipts which are needed to pay the bills. Stephanie Howard is getting calls from house managers about building funds and furnishing funds.

**8:30 a.m.** Missy Lohrey distributes all faxes that arrived last night and checks her calendar to see what is on today's agenda. Sharon Anderson gathers messages from the answering machines, collects the information

needed and begins returning calls. Sandy works on the payroll for the house corporation and finishes coding invoices. When she arrives every morning, the first thing Mary Costa notices is her telephone message light blinking. "It's fun to get voice mail and find out all the info before returning the calls. So satisfying when the members pay their bills on time! It's very satisfying to listen to the girls' problems and concerns and to help resolve them," Mary says.

**9:00 a.m.** Cindy Menges is cranking out materials for the National Council's conference call tonight. Missy works on reminder announcements for CCDs and chapter presidents about the upcoming Norma Andrišek Leadership Conferences. Diane records information about member contributions to the Delta Zeta Foundation and sends out receipts to donors. Sharon reads all the chapter president reports and sends copies to National Director Debbie Raziano. She processes orders for DZ DeZigns merchandise and packs the items for shipping. A member calls in to order Delta Zeta jewelry. Carla is answering phones and checking addresses from

alumnae rosters.

**9:30 a.m.**

One of the sorority houses has an opening for a house mother, so Toni works on the application, checking references and verifying information.

**9:45 a.m.** Pam finishes the

sorority ledger for John. She wonders if she caught all the errors. Her goal is to have it returned with no paper clips marking items to be changed.

**10:00 a.m.** Caren Hansel talks to a chapter consultant about her new address and prepares materials to be sent out to all chapter consultants in this week's mail. The phone calls start coming in to Toni now. The first call is from a house director. She wants to know if the chapter can replace the tile in the Annex. She'll have to get estimates and send them to Toni. Missy talks by phone with National Director Debbie Raziano about the RCC chapter evaluations which are going out in today's mail. Sandy gets deposits ready for Rosina to take to the bank at lunch.

**11:00 a.m.** The FedEx man just delivered the checks. This will take most of the day for Toni to check in the money and make sure that everyone paid their dues. The rosters came with the checks so Toni will check them in, also. Diane writes thank-you letters to major Foundation donors and sends acknowledgments to members who have donated Delta Zeta memorabilia.

**11:15 a.m.** Cindy and Missy sit down to go over the status on current projects. Resident computer troubleshooter Julie Foust gets her phone call for the computer crisis for the day. Someone lost a file (a large file!). Julie restores the file from last night's backup tape and the crisis is solved.

**11:30 a.m.** Sharon researches history for the committee headed by Phyllis Ross



which is updating Delta Zeta's history for the 100th anniversary in 2002. Pam and Caren eat quickly so they can walk during lunch. It's lunch time, but Rosina has to take about a dozen deposits to the bank and grab something to eat.

**12:00 p.m.** Missy finishes typing a letter and runs off to lunch.

**12:30 p.m.** Carla has gone to lunch so Caren covers the phones. Eight calls come within 10 minutes — four at one time! Help! Toni has three messages on voice mail awaiting her return from lunch. The first message is from a house manager who reports that there are carpenter ants in the house. Toni calls the exterminator who says he can go out to the house tomorrow and spray. Pam returns from lunch to find a message on her voice mail from a collegian who wants to be released from her housing contract because she has an internship.

**1:15 p.m.** Pam sends a fax to a CCD listing chapter members with a past due balance. They have a date party soon and need this information.

**1:30 p.m.** Rosina starts printing statements for members that are in the National Housing Corporation — about 800 statements a month. Carla is answering phones and updating addresses from returned mail. Diane files contribution forms and begins work on entering change of addresses and directory changes for alumnae and presidents. Sharon answers calls on the alumnae services toll-free line while sending out DZ DeZigns catalogs to members who have requested them.

**1:52 p.m.** Archie Belcher is preparing appointment letters for new CCDs.

**2:00 p.m.** Sharon runs a printout of names and addresses of members in the area for an alumnae chapter. A new alumna calls

and wants to know about alumnae chapters in her area. Sharon updates alumnae addresses in the computer database.

**2:15 p.m.** Julie gets an estimate of damage to a Delta Zeta house so that she can file the insurance claim and get the house fixed. The house mom will be happy with

that! The last house mom calls to report her payroll so Julie can now process everyone's paycheck. They'll really be happy with that!

**2:30 p.m.** Caren takes photos of new merchandise for DZ DeZigns. Mrs. Andrisek is working on a new Christmas catalog and needs the photos quickly. Missy has

four voice mail messages to return.

Rosina checks

**2:45 p.m.** Sandy gets a call regarding a magazine that was ordered but has not been received.

**3:00 p.m.** National Director of Extension Jamie Hammill Pyne calls Missy about a

letter that needs to go to a chapter. Diane types labels for new presidents and CCDs. Caren calls Xerox about four codes on the copying machine and scans Council members' signatures into the computer to use on future correspondence.

**3:15 p.m.** After a little checking, Sandy found out the magazine order was never sent in. She gets the checks signed.

# Continuing the Delta Zeta Experience After College

In the recent issue of *Sidelights*, mailed in May to all alumnae, a survey asking for opinions about *The LAMP* was included. To date, more than 2,500 alumnae have responded. Over and over again, alumnae told us they wanted to know more about being involved with Delta Zeta. Some wanted to know how to find other alumnae in their area, join an alumnae chapter or help a collegiate chapter. The questions below were taken directly from those survey responses. To answer them, *The LAMP* talked with the National Vice President of Alumnae Affairs Pam Cronenwett and several Area Alumnae Directors (AAD).

**Q: I don't live near an alumnae chapter or a collegiate chapter. How can I get involved?**

**A:** Contact your AAD listed in the directory of *The LAMP* and volunteer to serve on one of the area alumnae committees — membership, development or public relations. Financially support the sorority through donations to the Delta Zeta Foundation. Write an article for *The LAMP* or other publications. Identify outstanding potential new members and recommend those women you know will be attending a college where there is a Delta Zeta chapter.

**Q: How can I help a collegiate chapter?**

**A:** You can assist a collegiate chapter as an individual or as part of a group effort. Alumnae are needed to serve as chapter advisors and as members of house corporations. Offer assistance during rush. Offer to speak to a collegiate chapter about your profession or special interests. Serve as a mentor to a collegian. Volunteer your home for special meetings or events. Provide

oversight for pledging and initiation ceremonies. Support the collegiate chapter's fundraising and philanthropy projects. Contact the Regional Collegiate Coordinator (listed in *The LAMP*) for your region or the College Chapter Director for the chapter nearest you to offer your time and talents.

**Q: How can I find other alumnae living in my area for networking, friendship or to form a chapter?**

**A:** The Delta Zeta Sorority 1997 Alumnae Directory has a listing of alumnae by city, state and college chapter. To obtain a copy, contact Harris Publishing at 1-800-877-6554 or e-mail: [customerservice@bcharrispub.com](mailto:customerservice@bcharrispub.com). Or call the Alumnae Services Line, 1-800-6-ALUMNA, at National Headquarters and order a printout for your area. Your AAD and Area Membership Chairman also can provide this information.

**Q: How can I find out if there is an alumnae chapter near me? How do I start a new alumnae chapter in my area?**

**A:** Contact National Headquarters at 1-800-6-ALUMNA or contact the AAD for your area. Your AAD also can assist you if you are interested in starting a new chapter. The REACH structure defines an alumnae chapter as a group of alumnae within an area who want to be recognized as a chapter by National Council. The process for this recognition has been simplified and many of the requirements have been eliminated.

**Q: Are there other ways I can support Delta Zeta?**

**A:** Use the Delta Zeta VISA card. Order and renew your magazines through the Delta Zeta magazine program. Order items from DZ DeZigs. All of these programs provide revenue for the sorority which is then used to help pay for collegiate and alumnae programming.

**Q: How does the new REACH structure impact me as an alumna?**

**A:** The purpose of the REACH alumnae structure is to increase contact with a greater number of alumnae who are not involved or affiliated with an alumnae chapter. REACH provides greater and easier opportunities for involvement according to the level of participation each alumna desires.

**Q: With all that we have going on in our busy lives today, why is being involved with Delta Zeta important?**

**A:** Delta Zeta exists today because of the commitment of dedicated alumnae over the years. Beginning with our six founders, much of the work of the sorority has been done by alumnae volunteers. By continuing your Delta Zeta involvement, you will help assure that Delta Zeta will be here for your daughters and granddaughters. Renewed participation in Delta Zeta helps us reconnect with our roots and those women who have the same values we do. In today's mobile society, we need a sense of belonging and Delta Zeta provides an entire nation of ready-made friends.

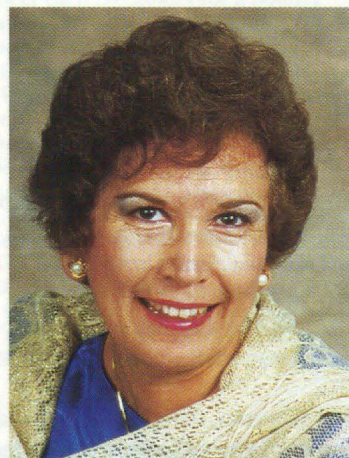
Althea and Jimmy have two children, both of whom are Delta Zetas from the Delta Alpha chapter at California State University at Long Beach.

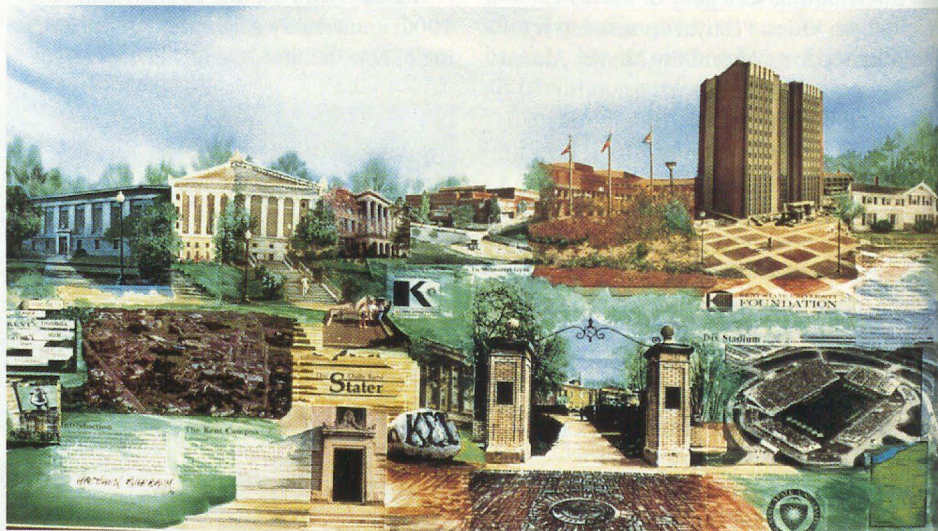

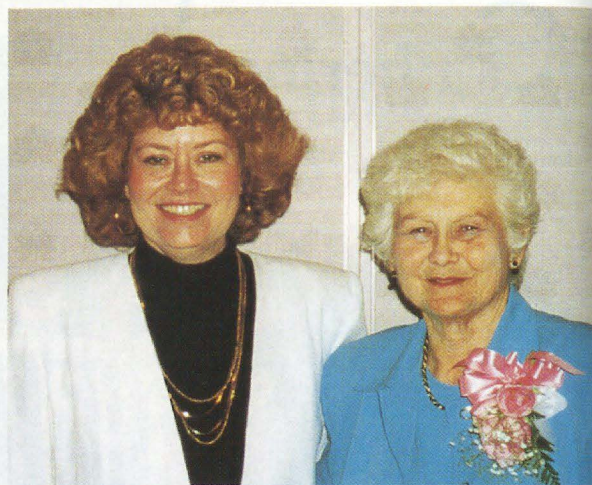

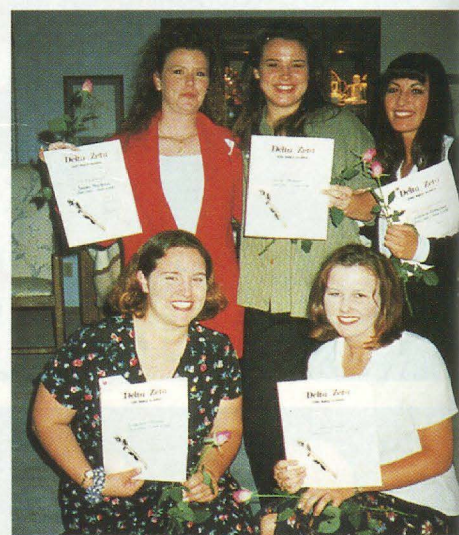

## More women joining sororities than ever

While news headlines continue to declare a Greek rush recession, National Panhellenic Conference membership numbers increased in every category. During the past year, the 26 sororities added 79,597 new members, up almost 2,000 over the prior year. Total NPC membership as of June 1, 1997, is 3,167,175.

Fifty-one new chapters were installed, compared to 39 in 1995-96. Today the number of collegiate chapters is at an all-time high of 2,920. And, during a time when alumnae members balance

careers or graduate school with family responsibilities, the number of alumnae associations increased by 16.

The NPC Extension Committee reported more than double the number of inquiries during the past year concerning new chapters and the affiliation of existing local groups.

The earliest reports of fall 1997 rush statistics show an increase in the number of women participating and higher quotas. The current statistics for fall rush support a growing interest in female Greek membership and the benefits and activities of affiliation.

## Brotherhood — the Substance of Choice

Three large fraternities have become the first of 64 national fraternities to ban alcohol in chapter houses by the year 2000 and more are expected to follow their lead. Farmhouse Fraternity has always been substance-free.

The new policy by Phi Delta Theta, Phi Gamma Delta and Sigma Nu is aimed at a new breed of fraternity members who are serious about earning a degree rather than how much and often they can drink. The ban covers all use and possession of alcohol on chapter property regardless of the age of the individual members.

Some reasons for the precedent-setting policy change are rising insurance premiums and increased costs to fix alcohol-inspired vandalism. National fraternity leaders feel it is important to return to their founding principles of friendship, scholarship, responsibility and integrity.

A Harvard University study in 1995 found that fraternity members were more likely than other students to binge drink. Over the years, alcohol has often been associated with difficulties at fraternities, many with lasting and grave consequences.

Dr. Robert Deloian, president of Phi Delta Theta's General Council said, "Unfortunately, fraternity life today is an alcohol-dominated culture. It has received a very negative image that — in most cases — is deserved. Fraternities have so much more to

offer and can play a vital role in student development. We need to focus on the positive aspects of friendship, leadership, scholarship, brotherhood and community involvement."

The key to the success of this program will be the support of all 26 NPC member groups. Alumnae and undergraduates need to give Farmhouse, Phi Delta Theta, Phi Gamma Delta and Sigma Nu fraternities priority when planning social functions and public relations credit whenever possible.

All 26 NPC sororities already have substance-free policies which are strictly enforced.

At its annual meeting in December, the National Interfraternity Conference passed a resolution which states: "The National Interfraternity Conference strongly encourages its member fraternities to pursue alcohol-free chapter facilities ... or other programs designed to address the misuse of alcohol and commits the NIC to support its members in this effort."

The National Panhellenic Conference and Delta Zeta strongly support the resolution and are asking all collegiate members to support the men on their campuses in their effort to become alcohol-free.

## Spring break means week of service to Iowa State's Becky Payne

Spring break marks a time when students have the chance to escape school and books for a week of freedom, traditionally spent enjoying fun and sun in some tropical location. Beta Kappa's Becky Payne, however, found a unique spring break opportunity that sent her on a service trip to the Appalachian Mountains.

Becky, a sophomore, joined eight other Iowa State University students and volunteered her spring break with the Appalachia Committee offered through a local church.

Early on a Saturday morning, Becky and the eight other students crammed themselves and their duffel bags into three cars and set off. Fourteen hours later, they reached their destination - Williamsburg, Kentucky.

While similar groups from past years had worked on many small projects, this group had one large project. Their mission was to build an additional bedroom to a mobile home in one week.

Becky said the assignment took on a personal tone after the group met the family they were assisting. Juanita was a single mother who had lost her job due to the physical strain of caring for her daughter, Michelle. Michelle is 20 years old, weighs only 70 pounds and suffers from cerebral palsy. She is blind and unable to speak.

Michelle requires a wheelchair to get around, but the hallways of the mobile home were too narrow for the wheelchair. Juanita strained her back by lifting and carrying Michelle to her bedroom and the bathroom. The volunteers built a bedroom for Michelle with a connecting bathroom, both with doorways wide enough to accommodate the wheelchair.

The task was not easy. According to Becky, most of the group possessed little or no carpentry skills. They had to learn to listen to those with experience and keep trying. Although the group of students was diverse, the plight of Juanita and Michelle

tugged at their hearts and they looked past their differences focusing instead on their common goal. They worried about the weather, the dwindling supply funds and the impending deadline.

Most importantly, Becky says the group used common experiences to form a bond of friendship and respect. Each evening the students shared their feelings about the day's work. They were able to relate to special moments and exchange friendship and laughter.

By the following Saturday, the group had achieved their goal — the job was complete. Although they sacrificed their opportunity for rest and relaxation, they gained so much more. They were reminded of how blessed they were. They also were inspired by the endless love and patience Juanita showed to Michelle.

When thinking back to the trip, Becky says she does not see nails and paint brushes. She remembers the people. She sees those who gave their time, their talent and their determination. She is often reminded of a phrase that best describes her spring break experience in Kentucky — "to give graciously of what is mine."

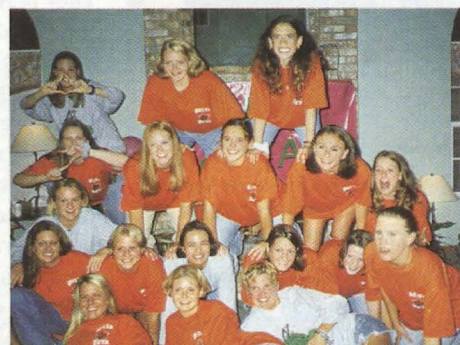

The Foundation is the tax-exempt entity of Delta Zeta Sorority. As its name so aptly implies, the Loyalty Fund is an opportunity to express one's loyalty to our sorority and to share the financial burden with our collegiate sisters, who are less able to bear the costs.

Each year, alumnae receive a letter from the Foundation Trustees asking for your contribution which will allow Delta Zeta's many philanthropic programs to continue. Contributions are then granted back to the sorority to help with the many collegiate programs, alumnae endeavors and scholarships. Like all National Panhellenic Conference sororities, Delta Zeta can no longer rely solely upon the new member, initiation and collegiate support fees if we are to sustain our sorority at the optimum level.

No gift to our Loyalty Fund is too large or too small - what is important is that everyone of us participates every year to the degree that she is able. But sad to say, only 4% of our alumnae membership gives to the Loyalty Fund. And so our goal is to raise that percentage each year.

Our 1996-97 Loyalty Fund Campaign now stands at \$80,400 and represents donations from our 80,000-plus mailable alumnae. Sadly, that works out to only about \$1 per year per alumna. But our collegians pay between \$270 and \$630 dues per year. How can we not commit ourselves to an annual Loyalty Fund donation?
