

The committee reviewed data on the college-bound students of tomorrow and trends and student profiles on campuses today. Discussion included the changing formats and schedules which need to be adapted to meet today's many challenges. New marketing and recruitment measures include using the computer, E-mail, the world wide web and other media available to our women. The seminar focused on the "emerging paradigms of membership recruitment" including the success of the "no frills rush" which was first introduced in the 1991 NPC Rush Resolutions. Many of our college campuses have finally adopted this "back to basics" approach to the formal rush process. Rush budgets have been cut, the use of release figures implemented, costuming and

is currently exploring this opportunity!


decorations reduced significantly, fewer skits, and a stronger emphasis on good one-on-one conversation has been highlighted. It was suggested that a study be conducted by the Rush 2000 Committee to review the progress made during the past five years. Another challenge for this committee is to continue to develop suggestions for interactive-type rush parties, especially those that could showcase our philanthropic efforts.

In keeping with this theme and in the interest of building "a climate of trust," 1996 introduces the concept of building a "code of ethics" by which our panhellenic women will be governed. Each collegiate chapter will be asked to devise its own code of ethics which will then be combined with the other member groups' codes to form a Panhellenic Code of Ethics. It is hoped that this process will emphasize the spirit of cooperation and the need for ethical conduct during the highly charged recruitment period.

The women also discussed the need to continue to "simplify" the membership process and the increasing role that continuous open bidding now must play in light of lower college and rush enrollment figures. We need to stress the importance of informal and year-round recruitment in our chapters and work to lift the negativity associated with the use of the COB process. The need to reach out to our incoming students through summer contacts was also discussed and encouraged. Guidelines for panhellenic contacts are outlined in the NPC Green Book. NPC's new membership recruitment program entitled "Links" was also reviewed. Campus panhellenics may order the accompanying videos and materials for their use.

A strong Greek system is one where good programming and academics is emphasized and numbers are strong — regardless of the method of recruitment. Women's groups are judged by their membership size and *rushing to Total and filling all Quota spaces* is an expectation of each of the national sororities.

The team spirit and cooperation between all the Greek women involved in this seminar as either participants or faculty was outstanding. There existed a true sharing of ideas and wonderful discussions of both successes as well as failures. Each of the rush

officers offered support to one another and to the Rush 2000 Committee for future panhellenic endeavors of this nature. We all look forward to rush and what it can become, with careful planning and guidance, in the years to come!

We all know what great things can be accomplished when we strive together for a cause. It is recognized that change is necessary if we are going to attract quality new members and remain competitive, but it is also sometimes difficult to embrace. Through good communication and education, as well as panhellenic spirit and ethical behavior, we can all work to adapt to the changing times and take Delta Zeta forward into the next century.

It's 75 Years for Delta Sigma

n Saturday, January 27, 1996, the Delta Sigma chapter at Northeast Missouri State University celebrated its 75th anniversary. A large number of alumnae from the St. Louis and Kansas City areas joined the members of the college chapter at the formal banquet and program.

Featured speaker was Dana McMillan, a 1972 alumna of Northeast Missouri State University who was a member and officer of the Delta Sigma chapter while she was a student. From 1983 to 1995 she served as Province Collegiate Director of Province XI. In 1990 Dana was honored as Delta Zeta Woman of the Year. Her

biography appeared in Show Me Missouri Women Vol. II.

Dana spoke on the system of national and province awards given by Delta Zeta to the most outstanding chapters in each category. She called attention to the many awards won by Delta Sigma chapter in Province XI including Outstanding Chapter of the eight in Missouri (earned repeatedly in the last twelve years), and four Crest Awards representing one of the ten best chapters of the 179 in the United States and Canada culminating in the Council Award as the best chapter, which Delta Sigma received at the

"Award winning is great," Dana told the audience, "but working hard and working together are what make this chapter special." The chapter's director, Bridget Stepnoski Morton, a 1982 graduate of

Delta Sigma, and Dr. Ruth W. Towne, College Chapter Director from 1953 to 1987 and faculty advisor, 1953 to the present, both agreed.

A quartet of chapter members, Sara Loveless, Anjanette Shine. Nicole Shine, and Jennifer Van Winkle, sang a special version of "The Rose." Tricia Buchheit, 1995 president, related the chapter's accomplishments in the past year. Newly installed president Katie Streitmatter closed with thanks to event co-chairs Amy Brewe and Christie Lutter.

On January 31, 1921, national organizers of Delta Sigma Epsilon sorority came to Kirksville and initiated twelve women as

charter members of the newly organized Iota chapter at Northeast Missouri State Teachers College. They included eleven students and Lucy Simmons, a member of the history faculty, who served as faculty advisor for 22 years. Dr. Pauline D. Knobbs, professor of Social Science Education, succeeded Dr. Simmons after she became head of the Division of Social Science in 1943. Ten years later College President Dr. Walter H. Ryle appointed Dr. Towne, profes-

A Great Event for Houston Alumnae Chapter

ashion Magic, the ninth annual luncheon and fashion show sponsored by Houston alumnae, was held on January 27, 1996, at the Junior League of Houston. Ninety percent of the proceeds were contributed to the Center for Hearing and Speech (a United Way Agency) and ten percent to the Nancy Jones Holliman Scholarship Fund.

The Center for Hearing and Speech, founded in 1947, is one of two oral education institutions for the hearing impaired in Texas. Since its founding, over 1,200 hearing-impaired children have learned to speak through tireless personal effort and intensive one-on-one instruction. The Center is dedicated to providing oral education for any child who comes for help,

regardless of the parents' ability to pay.
Delta Zeta contributes to the "Sponsor-A-Child" program.

The 1996 show was enhanced by the securing of corporate underwriting from Seitel, Inc. and from Unocal Corporation Foundation.

Decorations were based on the fashion magic theme. Table centerpieces were fashioned from black top hats filled with black and silver mylar confetti and playing cards. The hats were on square mirrors, with silver coins scattered around the table. Black napkins were used on white cloths and each place setting included a gift of a set of "magic cards" featuring the show logo. At one side of the stage was an enormous black top hat tilted to one side. Rising from the silver hat band was a set of gigantic face cards. Other sets of large cards were in front of the podium and the runway, with smaller cards scattered along the runway. Black and white balloons completed the room decorations. Two large color posters announcing the underwriters were displayed during the show, one at the entrance and the other on the stage. Seitel and Unocal were each given a complimentary table.

Event coordinator Ann Mathis began

the program with the introductions of the special guests from Seitel and Unocal, the underwriters.

Entertainment by the "Magic Madrigals" was a highlight of the program. The dance group was made up of hearing-impaired children from the kindergarten and five-and six-year old classes. They were dressed

in black slacks topped by white T-shirts printed with the top hat logo.

Following the entertainment, a fashion seminar was conducted by Barb Hornbeck, a noted fashion advisor and a Delta Zeta mother. The eight models included a Delta Zeta mom, a Delta Zeta daughter, the director of the Center for Hearing and Speech

and five Delta Zeta alumnae.

Deana Harris, director of Marketing and Public Relations for the Center, gave a brief overview of the Center, its programs and its evolvement into an excellent facility for educating children with hearing, speech and language difficulties. She also presented certificates of appreciation to

the underwriters.

Delta Zeta alumna, Sharon Kelley Shelton, LSU-Sigma, a past president of the Houston Alumnae Panhellenic Association, presented the fourth annual Houston Sorority Alumna of the Year Award. Ten nominees were called to the stage and each was given a crystal vase etched with a rose. Saranne Penberthy, Chi

Omega, was presented with a crystal bowl suitably engraved as the 1996 Alumna of the Year. The selection committee consisted of representatives from two panhellenic member sororities and three from the business community. A Delta Zeta acted as the non-voting administrator. The sorority representation rotates among the panhellenic members yearly. The presentation of this has generated additional publicity and increased attendance the past three years.

Throughout the program, door prize drawings were held. Door prize tickets were available at the show and prior to the show via a "request for tickets" card included in the invitation. A reprint of this card was also included in the Houston alumnae newsletter, *Houston Highlights*, mailed to every Delta Zeta in the area three weeks prior to the date of the show.

Delta Zeta once again presented a beautiful, well-planned event and raised \$10,923.00 for the Center for Hearing and Speech and the Nancy Jones Holliman Scholarship Fund. Everyone — guests, Delta Zeta members and the Junior League personnel — all agreed that it really was magic.



Recently our Salt Lake City alumnae received a Distinguished Community Service Award from the Association of Retarded Citizens. Praise for their long-term assistance to the Work Activity Center for Handicapped Adults follows:

"For over 37 years the ladies of Delta Zeta have met the specific needs of hundreds of people with mental retardation. The majority of these ladies are in their 70s, 80s or 90s. Yet in spite of their age and accompanying frailties, they continue to give of their time and talents. Fund-raising, gifts, parties, boutiques, garage sales, and any other "call to action" receives an immediate response.

"In the early years, these ladies would host Christmas parties for individuals with varying age and levels of disabilities, ensure that Santa paid a visit, that food and entertainment was provided, and that each person received a gift chosen just for them. Whenever individuals are in need, the ladies are there. They have, for over 30 years, provided gifts to people attending the Work Activity Center. Over the years they have donated TVs, VCRs, a piano, exercise equipment, silverware, recliners, assistive devices, basketball standards, computer software, tablecloths, furniture and many other items to aid both the program and its participants. These gifts have significantly enhanced the lives of the people who received them, and helped them be more independent.

"Most of all, the ladies of Delta Zeta have unselfishly given their hearts and souls to people with mental retardation. Their assistance is only a phone call away. They help without the smallest thought of reward for themselves and it is time they were recognized for all they do and have done for people with mental retardation."

llen Stavros' life is filled with loves and passions. Fortunately for the Delta Zeta Foundation, sorority is one of her loves.

Delta Zeta, after all, is where Ellen organized her first major fund-raiser, something she does professionally now in her position as Executive Director and Chief Operating Officer of Florida House, an education center for Floridians in Washington, D.C.

"If we were in a foreign country, we'd be an embassy," she explained. "We provide information to Floridians in the D.C. area, whether they're working, living or visiting."

The job description seemed tailor-made for Ellen. Her love of history fit in perfectly with Washington. She thrills at passing Robert E. Lee's house every day on the way to work from her home in nearby McLean, Virginia. And, as a former high school history and government teacher, she gets the opportunity to work with the visiting students to explain how Florida "fits in" to the federal government process. And Florida House itself adds in with Ellen's love of history—it's furnished in antiques.

Her experience working for Congressman Mike Billrakis on the Hill and as a meeting planner for her father's business in Florida,

plus her volunteer fund-raising experiences with groups such as the St. Petersburg Museum, theatre, Junior League and Delta Zeta also equipped her for raising Florida House's annual budget of \$200,000. That's a big step from her first effort when she and Pat Canady Rosser, Georgia Southern-IN, organized a visit by the Gallaudet Dancers and Actors to the Clearwater area. The appearances raised \$20,000 for Gallaudet University and another \$20,000 for Delta Zeta.

Ellen attributes many of her skills today to her mentor Lucile Crowell Cooks, Miami-A who was always encouraging Ellen to take on new challenges saying, "You can do that, Ellen." She thanks Delta Zeta, too, for leadership skills.

Ellen uses her leadership skills daily as she works with CEOs from major Florida corporations like GTE, Universal, Disney and AT&T. She works with lobbyists and the Florida Congressional delegation, too. Florida House's "annual gathering" of lobbyists and Florida congressmen raises between \$50,000 and \$60,000 each year. In anticipation of the 25th anniversary of Florida House, Ellen is launching an endowment campaign to raise three to five million dollars.

As a Foundation trustee, Ellen sees a similar role for herself. She feels like her main responsibility will be to raise necessary funds for scholarships and education. "We need to provide a service training and educating college women to prepare them for

Ellen Stavros has a love of family, job, country, religion and sorority. And, then there are her passions — like art, history and books. And, the Delta Zeta Foundation loves welcoming Ellen as one of its newest trustees.

Two Mystery Photos Identified! Here are More!



Shortly after publication of the spring issue of The LAMP, Curator/Archivist Betty J. Gurr-Tomblinson received letters from four observant Delta Zetas. Margaret Telleen Houghton, Illinois-AB, wrote to tell us that photograph #2 was Dorothy Jeanne Hill, who had been a $B\Phi A$ at the University of Illinois, graduating with a degree in library science in 1933.

Just a little later, Eve Myers Hughes, Wittenberg-BX, wrote that she recognized Dorothy Jeanne from the 1931 Wittenberg vearbook, but did not see her in 1932. So, apparently she had affiliated with the ВФA chapter at Illinois.

She eventually went to the Congressional Library in Washington, D.C., and was married to Joseph H. Gersack. Some time later, they moved to either New Mexico or Arizona. Dorothy died in January 1983. She had been initiated into Delta Zeta in 1941.

Photo #4 was recognized by Lillian Dean Huffstetler and Jayne Harrison Beszhak as a picture of Kappa members at the University of Washington. As Javne wrote, "After 50+ years, it is hard to recall names."


