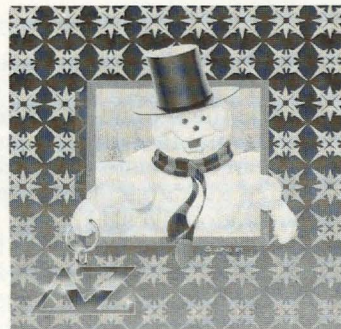

Elizabeth Baker Devereaux is 1984 Woman of the Year

Elizabeth Baker Devereaux, Ohio State-Θ, has been named 1984 Delta Zeta Woman of the Year.

Elizabeth is the second Past National Officer but the first Past National President to be so honored by Delta Zeta. She is an Associate Professor in the Department of Psychiatry at Marshall University School of Medicine in Huntington, West Virginia.

Born in Huntington, Elizabeth Devereaux graduated from Ohio State University with Mortar Board honors and a Bachelor of Science Degree in Occupational Therapy. Named outstanding pledge in her class, she was initiated into Theta chapter and served in several chairmanships and as a collegiate delegate to National Convention.

As an alumna, Elizabeth was area recommendations chairman, a charter member and president of the

Marietta-Parkersburg alumnae chapter and a charter member and Delta Zeta delegate to the Mid-Ohio Valley Area Alumnae Panhellenic.

She was voted Province IV Outstanding Alumna and served successively as Province Alumnae Director and Province Collegiate Director; then as National Director, National Vice President of College Programs and as National President. She is currently a member of the Board of Trustees of the National Historical Museum.

In reflecting, Elizabeth said, "Delta Zeta has meant much to me over the years, and one of the things that has had considerable effect on my life occurred when I was working at the province level, doing workshops, writing, working with the chapters. This provided the opportunity to do things I DIDN'T KNOW I COULD DO! And it was an exhilarating experience when I realized that I COULD do these, and do them reasonably well and get results. And of course all these skills were transferable to my professional work, and I have not stopped using them, but continue to build on and refine them."

She continued, "We hear a lot about creating link-ages and networking these days, but the original of these - for me - began again when I was working on the province level and then the national scene. It's one of those things that sororities, at least, have been doing well for years."

Active in occupational therapy and mental health-mental retardation related fields since her graduation, Elizabeth earned a Master's Degree in Social Work from West Virginia University in 1976 and has been a member of the Marshall School of Medicine faculty since 1977. She is a member of the Academy of Certified Social Workers, a registered and licensed Occupational Therapist, a Fellow of the American Occupational Therapy Association and a member of the World Federation of Occupational Therapists.

More than 30 Continuing Education seminars are listed to her credit and she has actively served in a number of capacities in the state and national associations with which she is affiliated. She was the Governor's appointee to the first West Virginia Board of Occupational therapy and served as president of the National Association of Activity Therapy and Rehabilitation Program Directors. She was the recipient of its Distinguished Service Award in 1978.

Some 130 plus workshops have been planned, prepared and/or presented under her leadership. She has authored some 20 grants and 11 proposals in her field, served as on-site evaluator for American Occupational Therapy for the Veterans Administration Medical Center and Huntington State Hospital in West Virginia and at the University of Kansas. Active in university departmental and community professional organizations, Elizabeth has authored more than 20 professional publications and research papers.

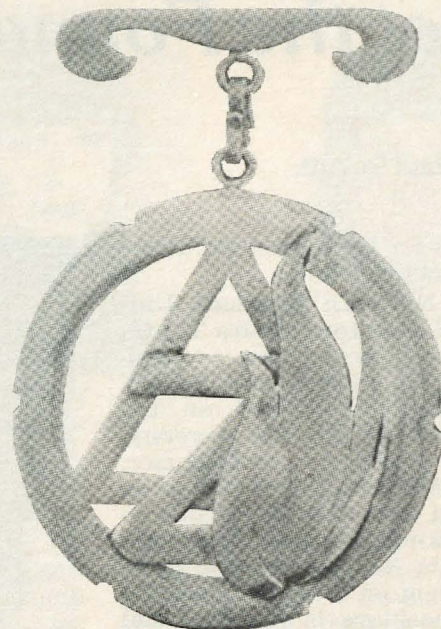
Honors include listings in 37 different volumes or editions of *Who's Who*, both regionally and nationally. In 1982 she received a Certificate of Appreciation from the American Medical Association's Committee on Allied Health Education and Accreditation and in 1983 received the AOTA Service Award.

Elizabeth is the mother of three grown children, sons Greg and Steven and daughter, Jan Devereaux Lance. Among her Delta Zeta relatives are sister-in-law Lu Ann Thimmes Baker, OSU-Θ, Worthington, Ohio; our 1970 Convention Initiate Jean Marie Devereaux Anderson, Virginia Beach, VA, another sister-in-law and a cousin, Vonnie Moore, LSU-Σ, Arlington, VA.

"Caring Relationships," the topic of Elizabeth's May 1984 address to the American Occupational Therapy Association in Kansas City sums up her philosophy of dedicated service to others. One of her most recent honors came at this convention when she was given the association's highest honor, the Award of Merit.

Liz, as she is affectionately known by all those who know and admire her, is one in whom Delta Zetas across the nation can share pride and gratitude for her many talents and her service to others. A truly nationally distinguished sister honors us with acceptance of the 1984 Woman of the Year Award.

The second tenet of our Creed, "To those whom my life may touch in slight measure, may I give graciously of what is mine," expresses the intent of our Founders Memorial Foundation. Won't you take time today to share your love and generosity?

Where Do Councils Come From?

Now that the time has arrived for concerned Delta Zetas to make recommendations to the Nominating Committee of those women they feel are qualified to serve on the National Council for the 1984-1986 biennium, perhaps we should look back to see where our Council members have begun their Delta Zeta careers.

Each of them was initiated into a collegiate chapter and went on to serve in alumnae chapters, on the province level, or on a national committee. What is required of these women when they reach the top administrative level? The prime requisite is time - time to read and answer the stacks of mail - time to answer and make all those phone calls - time to travel - time taken away from jobs, family, local commitments.

What talents are needed? Tact, diplomacy, the ability to like and handle people and situations which arise daily, and sometime nightly; the ability to think not only for the present, but the future of Delta Zeta nationally, and the individual as she enters the scheme of things.

The rewards are great - the making of many, many friends, of helping where help is needed - and pride in the accomplishments.

Not surprisingly the largest number of Council members has come from Alpha chapter. All but Anna Keen Davis of our Founders served on Council, with three of them as National President. Altogether, fourteen from Alpha have been Council members over the years.

California's Mu chapter comes next with a total of seven. With six there are Epsilon, Theta, and Alpha Alpha chapters, and Zeta follows with five. Beta, Delta and Lambda had four each. Those with three are Iota, Eta, Nu, Xi, Alpha Sigma and Alpha Psi.

Many chapters had two of their initiates reaching the top Council level, Gamma, Psi, Omicron, Sigma, Tau, Alpha Beta, Alpha Gamma, Beta

Kappa, and Beta Rho. The following chapters each had one member representing them on council: Kappa, Omega, Alpha Epsilon, Alpha Upsilon, Alpha Pi, Alpha Iota, Alpha Kappa, Alpha Chi, Alpha Omicron, Alpha Tau, and Alpha Omega.

Remember that the Beta chapters did not come into existence until after Delta Zeta's silver anniversary. There are also these chapters

with one Council member each: Beta Lambda, Beta Theta, Beta Phi, Gamma Alpha, Gamma Delta, Gamma Lambda, Gamma Nu, Gamma Upsilon, Delta Phi, Delta Omicron, Delta Theta, Delta Iota, Delta Tau, Epsilon Alpha, Epsilon Lambda, Epsilon Upsilon, Epsilon Tau, Epsilon Mu, Theta Epsilon, Zeta Zeta, Zeta Phi, and Iota Nu.

Your Privilege ... Nominations for National Council Officers

The members of National Council are elected from the members at the biennial National Convention as provided in the Constitution and Code of Delta Zeta. Every Delta Zeta has the privilege of sharing in this democratic procedure by making recommendations to the Nominating Committee. This may be done by an individual, an alumnae chapter, an alumnae club, or a collegiate chapter. The Nominating Committee invites your help and will give careful consideration to all recommendations received.

The Nominating Committee is charged with selecting a slate of the best qualified nominees for members of National Council. Thus the welfare and progress of the sorority are directly dependent on the good judgment exercised by the committee. The decisions of the committee will be based on the recommendations received from you or your chapter.

standing with the sorority. She must be a member who already has strong leadership experience at the local and province level, who has shown a capacity for the effective administration of assigned tasks, and who has the time required for this demanding service, including freedom to travel.

Delta Zeta's Woman at NASA

In 1983, Americans watched astronaut Sally Ride and her fellow crew members orbit the earth in the space shuttle. She had become the first woman in space from the United States.

In 1984, history was again made within the National Aeronautics and Space Administration. This time, it involved a Delta Zeta.

Dr. Carolyn L. Leach Huntoon was named Special Assistant to the Director of the Johnson Space Center in Houston. She is the first woman to be named to the management staff of the center.

The former Delta Zeta Woman of the Year said her reaction to the appointment was one of "complete excitement and enthusiasm."

It is the latest in a long list of achievements by Carolyn, who was initiated into Epsilon Beta Chapter at Northwestern State University in Louisiana. She received both a master and doctorate in physiology from Baylor College of Medicine. Following completion of her doctorate in 1968, Carolyn joined the Johnson Space Center as a research associate for the National Research Council. She then went on to work as a scientist in the Apollo, Skylab, Apollo-Soyuz and Shuttle programs.

Prior to moving to the director's team, Carolyn was chief of the biomedical laboratories branch. She coordinated a program to study man's response to the weightless environment induced by space flight.

"This program resulted in the required confidence to commit man to long duration space flight," Carolyn said. "The published reports of these studies stand as unique source information for future space flight program planning."

Throughout her 16 years at the Johnson Space Center, Carolyn has had many opportunities to work with center management. She said she has always been impressed by the caliber of individuals attracted to the space program.

"For this reason, when asked to join our center management, I not

only felt I was prepared but was very excited about the possibilities of making a contribution at this time in my career."

As the third-ranking person at the space center, Carolyn's major responsibilities lie in day-to-day management. She works closely with NASA Headquarters in Washington, D.C. on issues such as international relations as they relate to the space center. She also approves all presentations and publications that go out from technical personnel. The task is one she particularly enjoys because it allows her to keep in contact with colleagues in the physical and life sciences.

Carolyn has served on three Astronaut Selection Boards. When the first women astronauts were chosen in 1978, very few women held technical positions. Since then, numerous jobs previously held by men are now held by women.

"The reason, I believe, is that just as women are visible in the many

other previously male-dominated organizations, they are becoming recognized for their qualifications and their contributions to programs."

Yet Carolyn said she cannot envision an all-female flight crew.

"Perhaps this is far beyond my current thinking, but I prefer to think of crews being selected and trained and flown in space that are best for the job that is defined."

Indeed, this Delta Zeta's experience and insight into the space program helped make her the best choice for the position she now holds on the management staff.

"I always felt that I would continue working in the field that I have chosen as long as I felt like what I was doing was very important and I was having fun," she explained. "This job that I am now doing is certainly one that I feel I can do well, that I am making a contribution in, and I am having a lot of fun."

Councils (continued)

Can you identify these National Officers from your chapter? As the chapters mature, we can expect more and more nominations will come from the newer chapters. The present National Council runs the gamut from the oldest chapter, Alpha, to Iota Nu. The personnel of the National Council to be elected at the 1985 convention will be changing since there will be several vacancies. The Nominating committee never knows until it polls the presiding Council as to how many are willing and able to again look at the tops of tables and desks overflowing with mail and reports, to say nothing of families who are no longer willing to share wife and mother most of the time.

The tenure rule also will hit some of the members as no elected officer may serve more than twelve consecutive years on Council, and none may serve consecutively more than two terms in the same office.

Home Economists Honor Jean Liles

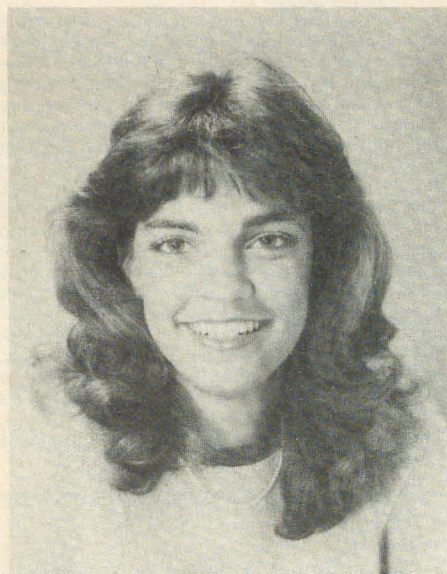

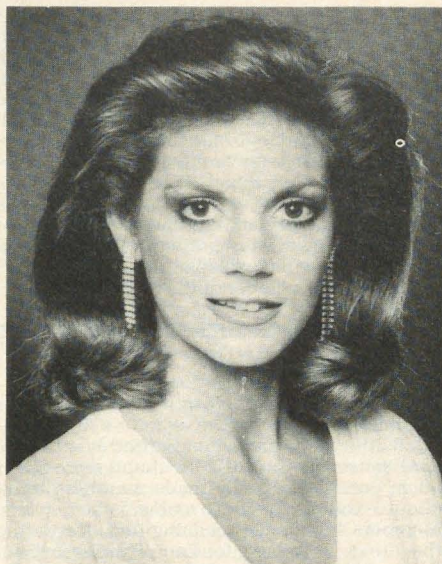

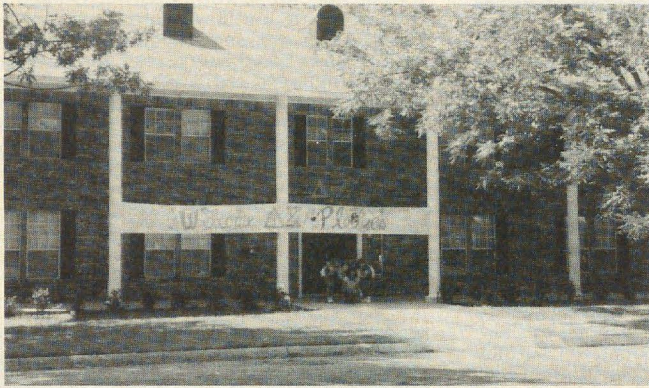

Hearing Help Grants

The Founders Memorial Foundation annually awards grants to alumnae chapters to assist with local philanthropic endeavors. These are made possible by alumnae chapter contributions to the Founders Memorial Foundation Hearing Help Fund. This year grants were awarded to:

Cleveland Eastside Alumnae for the Millridge School for the Hearing Impaired. The \$250 grant will be added to \$250 donated by the alumnae chapter to purchase a keyboard for the school choir. "The Millridge Center aims to integrate, as fully as possible, the child with a hearing loss into the world of sound and the mainstream of society." Cooperatively used by fifteen school districts, the Center opened its doors in 1969. Cleveland Eastside alumnae have supported the Center since 1977.

Columbus (Ohio) Alumnae for the Ohio School for the Deaf. The \$100 grant will be used to purchase two loaner hearing aids to be used by students when their aids are being repaired. Columbus alumnae have worked with the school for nine years donating proceeds from a Flame Fantasy luncheon and style show.

Huntsville Alumnae for the Well Child Clinic, University of Alabama School of Primary Medical Care. The \$225 will enable the staff of the Well Child Clinic to broaden the scope of the "Delta Zeta Prescription Fund for Healthy Ears" to include vitally needed medication and diagnostic testing not currently provided. This unique project began two years ago when the alumnae chapter established a fund to pay for medication to treat ear infections in patients whose parents simply could not pay. During the two years the fund has been in operation, approximately 200 patients have received medication paid for by the fund.

Oklahoma City Alumnae for the Oklahoma Society for Crippled Children. The \$275 grant will be used by the Speech Therapy Program to purchase a tape recorder, three reels of tape and other testing materials. Oklahoma City alumnae raised \$1,900 at their 1983 Flame Fantasy which was presented to the society for use in their hearing programs. A Mono Fonator, speech training tool for helping deaf and blind students learn to speak was purchased for \$1,400.

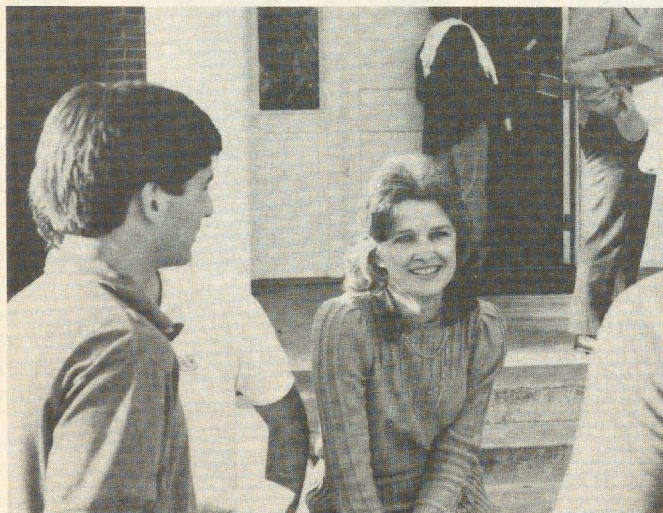

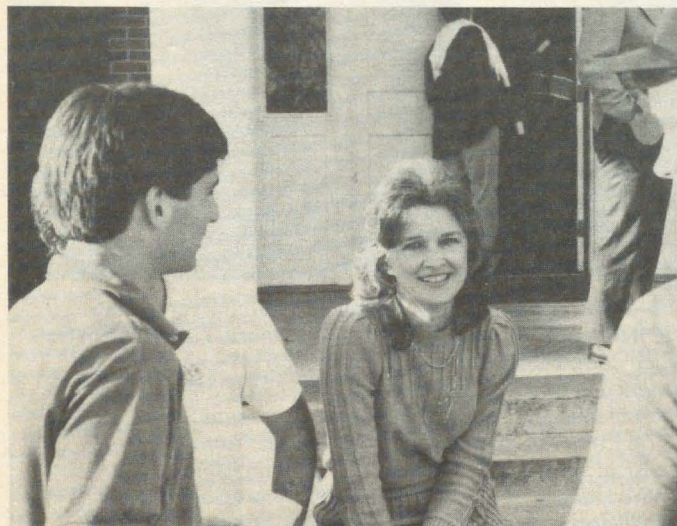

Alumnae Profiles

The latest honor for 1951 Woman of the Year **MILDRED FREBURG BERRY, Iowa-I**, is the Rockford (Illinois) *Register Star's* Excalibur Award, which is the highest award the city can give for community service. Mildred also was recently named to the top ten list of Rockford's most influential women and was honored with a \$25,000 fund in her name. A long time speech professor at Rockford College and a nationally recognized authority on speech pathology, she received the award in recognition of her outstanding contributions to the community which span more than half a century.

MONICA HOUSLEY, Northeastern State-ΔΦ, is Director of Public Information and News for the Texas State Technical Institute at Waco. Prior to joining the TSTI-Waco staff in 1982, Monica was assistant director of communications at Bacone College in Muskogee, Oklahoma. From 1977 to 1979 she was editorial writer and managing editor for *Muskogee Festival Magazine* and *Lake Living Magazine*. Graduating from NSU in 1979 with a degree in journalism, she served as charter president of the Muskogee alumnae chapter of Delta Zeta. Monica was married to Allen Faulkenbery in early December.

JUDY PIETSCH DICKINSON, DePauw-Δ, has just completed a term as president of the Bloomington-Normal Alumnae Panhellenic. During her year the group exceeded their goal of raising \$1,500 for the three scholarships they give annually. In addition, the Panhellenic recognizes sororities at Illinois Wesleyan and Illinois State with the highest GPAs and most improved GPAs. The Panhellenic received a citation from National Panhellenic Conference in 1983, one of 24 presented nationally.

The *Wall Street Journal* recently carried an interesting article about **HAZEL BRANNON SMITH, Alabama-ΔΓ**, the 70 year old owner and editor of the *Lexington (Mississippi) Advertiser*. Hazel was awarded a Pulitzer Prize in 1964 for her editorials advocating the rights of blacks, an unpopular position to take in Mississippi in those days. She wrote in the face of great pressure and opposition, including violence by segregationists and a boycott of her newspaper. The *Journal* also went on to say that Hazel Brannon was barely out of the University of Alabama when she borrowed \$3,000 to buy her first newspaper and remarked that "she was a former Delta Zeta beauty queen partial to Hattie Carnegie hats, spike heels, Cadillac convertibles and the attentions of a flock of suitors."

SANDY SHUMARD LEDBETTER, Central Arkansas-EΞ, was recently named executive director of the Arkansas state Democratic party. A former teacher, Sandy served as the 1984 campaign coordinator. 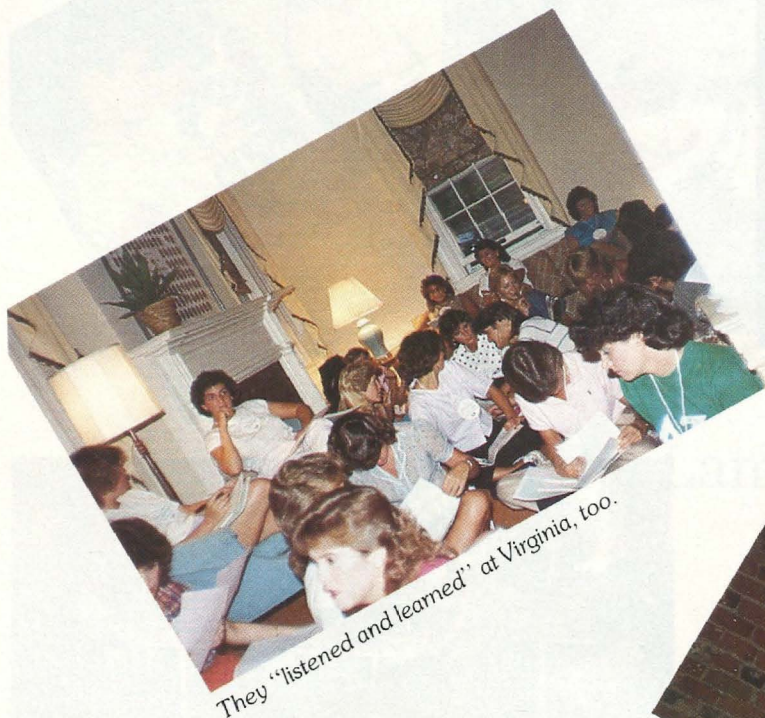

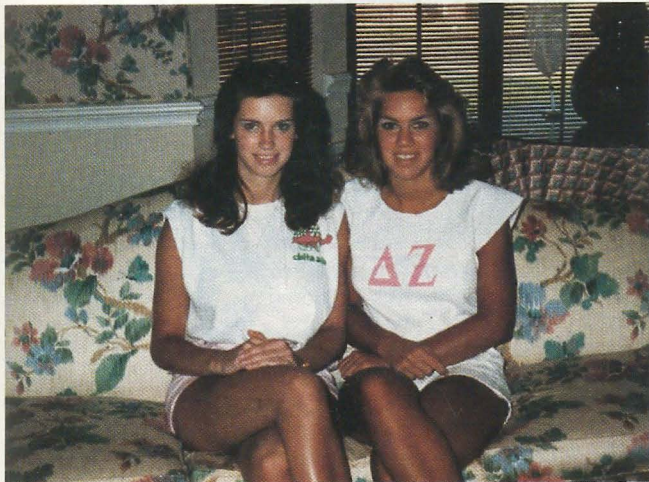

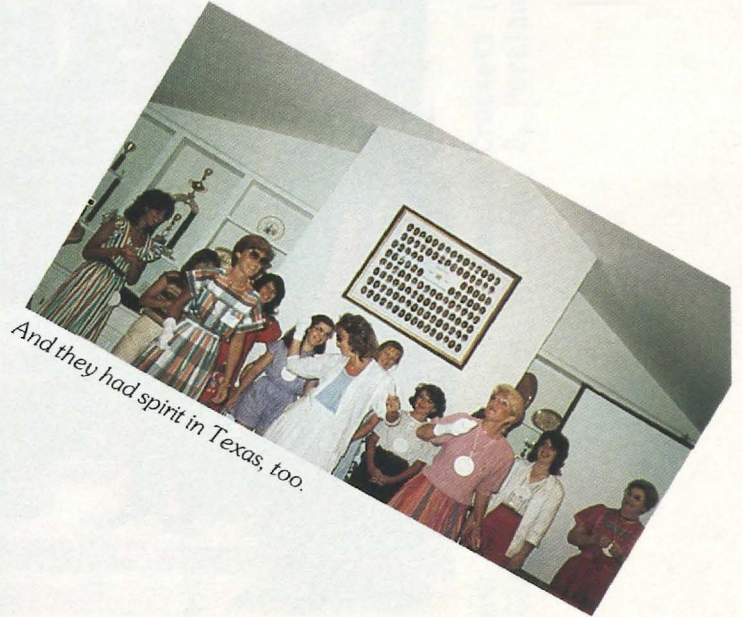
