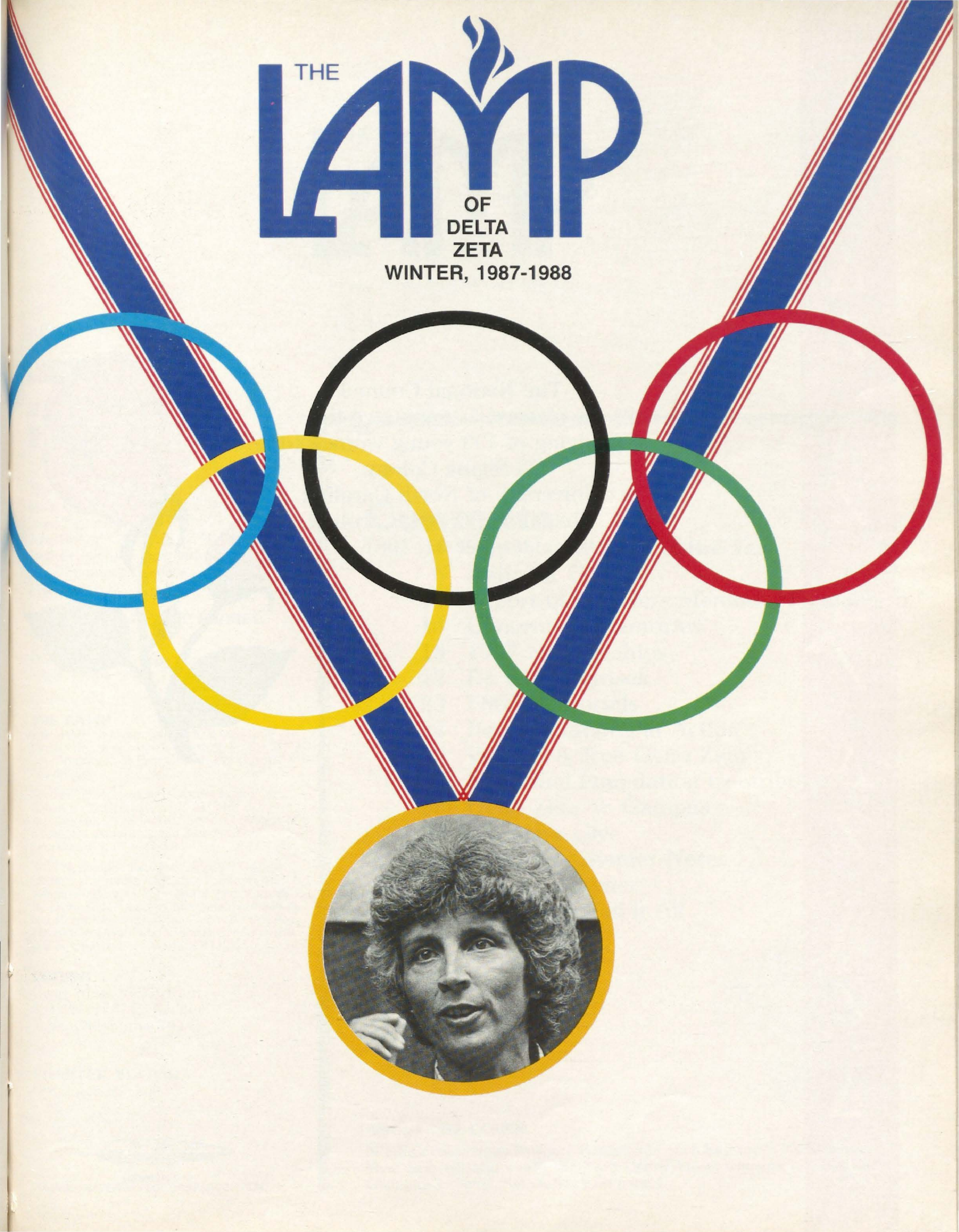

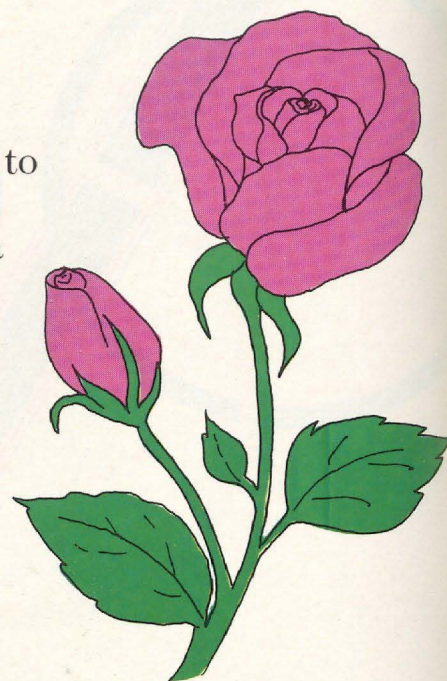

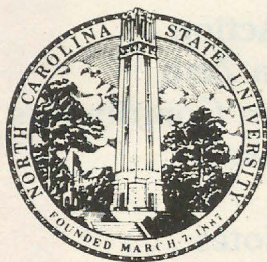

# Kay Yow, Woman of the Year



Kay Yow, 1987 Woman of the Year



The National Council is honored to announce that Delta Zeta's 1987 Woman of the Year is Kay Yow, East Carolina State University-ZA chapter.

Kay is Women's Basketball Coach at North Carolina State where her Wolfpack team has appeared in post season play for 11 consecutive seasons, including invitations to all five NCAA Tournaments. The Wolfpack women have appeared in the Associated Press Top 20 Poll for nine of the last ten years and won ACC Championships in 1980 and 1985.

Kay is also the Head Coach for the United States Women's Basketball Team for the 1988 Olympic games in Seoul, Korea.

One of the most respected members of the coaching community, Kay has proven to be a winner on both the national and international level. Newspaper headlines read "Peers praise Yow as coach, person," "Thankful Yow wows 'em in Moscow" and on and on.

Quotes are numerous, too. "She is very concerned about her players' well-being, and there are not too many coaches nowadays that are like that" said Cheryl Miller, USC All-American who played on the 1984 Olympic Team.

"She has a way of blending players together, and that's the thing you need to be able to do as an international coach," said former Wolfpack player Trudi Lacey, who recently was named head women's coach at Francis Marion College. "Her coaching skills are outstanding and her people skills excellent," said Lea Plarski, coach at St. Louis Community College and a member of the Amateur Basketball Association of the USA committee that recommended Kay for the job.

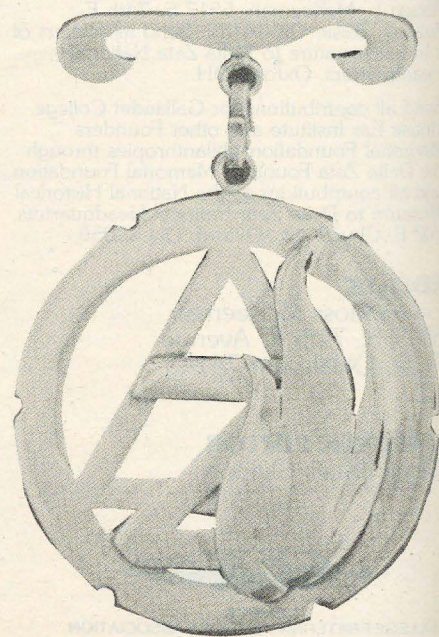
And so it goes. But where did it all start? Kay was born in Gibsonville, North Carolina. The Yow kids — Ronnie of Greensboro, Kay, Debbi, assistant director of the Gator Club at the University of Florida, and Susan, basketball coach at Drake University in Des Moines, grew up with basketball. Games in the yard, games with the neighborhood boys, games on the high school team. Kay's high school record of 52 points in a single game still stands.

After graduation from East Carolina, Kay taught English and physical education and coached the women's basketball team at Allen Jay High School. In her first year, they won the conference championship. She then

coached at her alma mater, Gibsonville High School and later at Elon College while working on her master's degree at the University of North Carolina — Greensboro.

In 1975 she accepted the position of Head Coach for NCSU's Wolfpack women's basketball team. In 1984 Kay served as an assistant coach for the gold medal-winning U.S. Olympic team. In past years she has also worked with seven other U.S. select teams, including Pan American, World University and World Championship squads.

In the summer of 1986 Kay led the USA team to a gold medal at the Goodwill games in Moscow with a brilliant victory over the Russians. She then duplicated that feat in August at the 1986 World Championships. The triumph in July marked the first time in 28 years that the Soviet Union had lost a major tournament and while the Goodwill Games victory was the type of accomplishment







that is rarely repeated, the Americans managed to do it at the World Championships and establish themselves as the world's best women's basketball team.

Memberships in honorary and professional organizations include the Board of Directors of the Women's Basketball Coaches Association, Converse Coaching Advisory Staff, North Carolina Amateur Sports Festival Committee, member and chairman for the American Intercollegiate Athletics for Women. Kay is also the co-sponsor of the Fellowship of Christian Athletes at North Carolina State and is very active with the Sunday School program at Cary Alliance Church. As busy as she is, she rarely turns down an opportunity to speak at a church or school function.

When Kay was hired at North Carolina State 12 years ago she became the first women in North Carolina to become a full-time coach in collegiate

athletics. She has been described as a teacher and administrator whose coaching expertise and motivation of young people have earned her international fame.

Delta Zetas everywhere can look to Kay Yow with pride as she exudes a value system that sets a standard for our society and our sorority. As a role model she will reflect honor on Delta Zeta as 1987 Woman of the Year.

## Merry Adamcik

Merry Westbrook Adamcik started her Delta Zeta involvement as president of Delta Theta chapter at the University of Houston. A Top Ten Student, she was Mortar Board, *Who's Who* and Dean's List. Not surprisingly, she received the FHM and GML awards and went on to be CCD, Panhellenic Advisor and member of the House Corporation for her chapter. She was

Texas PCD for six years and served on many a convention committee.

Her time is split nowadays between family, career and Delta Zeta. Husband Roy teaches history in the high school and coaches baseball, which accounts for he and eight-year-old Scott being avid Astro fans. Baby Emily is the apple of everyone's eye.

### SCHOLARSHIPS:

- A. \$13,000 given for 1985-86 school year to 28 recipients.
- B. \$13,100 given for 1986-87 school year to 28 recipients.
- C. ELIZABETH COULTER STEPHENSON SCHOLARSHIPS: 38 scholarships totaling \$9,900 were awarded during the 1985-86 school year, and 34 scholarships totaling \$7,860 were awarded during the 1986-87 school year.
- D. GAIL PATRICK VELDE MEMORIAL SCHOLARSHIP was established by the FMF Trustees from a \$10,000 gift from Gail's estate. The \$500 scholarship is by application and awarded to a Delta Zeta member entering her junior or senior year who is seeking financial assistance.
- E. CAROLYN ROWE TRUST FUND provided a graduate counselor at Kent State-ΓK chapter for the 1985-86 school year.
- F. BARBARA S. ROBEL SCHOLARSHIPS: Two \$500 scholarships given to the Association of Fraternity Advisors on behalf of Delta Zeta Sorority in honor of Barbara S. Robel, Kansas State-Α. As Advisor for Greek Affairs at Kansas State University, Barbara participates in the AFA and served as president in 1985. These scholarships enabled several advisors to participate in a Senior Managers Forum.
- G. Dr. Alan H. Becker gave a generous gift of stock to the Founders Memorial Foundation benefiting the CATHERINE ANN BENJAMIN BECKER MEMORIAL SCHOLARSHIP FUND. Sale of this stock increased the fund principal by \$12,408.
- H. A \$750 contribution to the Scholarship Fund was received through Delta Zeta Sorority from the estate of Elvira A. Rau, University of Illinois-AB.
- I. LOCALLY ADMINISTERED SCHOLARSHIPS were

received as follows: (scholarship amounts are determined by interest earned on fund principal)

- 1. SHARON ROBINSON ELLIOTT PROVINCE XVII SCHOLARSHIP FUND — \$4,120. This scholarship, in memory of Sharon Robinson Elliott, Pan American-ΘΘ, is given annually by application and awarded to a collegian in good standing in a Province XVII chapter. This fund was established with contributions from Pan American-ΘΘ chapter and the Edinburg/McAllen alumnae chapter.
- 2. GAIL PATRICK VELDE PROVINCE XV-S MEMORIAL SCHOLARSHIP FUND — \$3,228. This scholarship is by application and awarded to a junior or senior collegian in good standing in a Province XV-S chapter. This fund was established by the Los Angeles alumnae chapter.
- 3. BEVERLY BALDWIN BURNSED/ALPHA SIGMA SCHOLARSHIP FUND — \$2,500. This scholarship, given annually in honor of Beverly Baldwin Burnsed, Florida State-ΑΣ, is by application and awarded to a collegian in good standing in Alpha Sigma chapter. This fund was established by the Florida State-ΑΣ chapter.



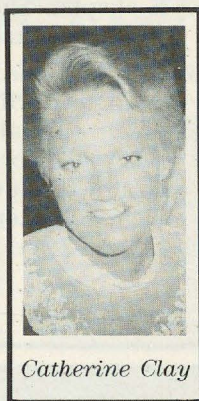

4. **AMARYLLIS PICKETT BARNES SCHOLARSHIP FUND** — \$3,663. This scholarship, given annually in memory of Amaryllis Pickett Barnes, Oglethorpe University-BΦ, is by application and awarded to a collegian in good standing in Delta Delta chapter. This fund was established by the local Amaryllis Pickett Barnes Scholarship Fund and Delta Delta chapter.
5. **EVELYN ADAMS COSTELLO PROVINCE VI SCHOLARSHIP FUND** — \$3,000. This scholarship, given annually in honor of Evelyn Adams Costello, Knox College-N, Past National President, is by application and awarded to an undergraduate collegian in good standing in a Michigan chapter. This fund was established by Province VI Delta Zetas.
6. **SUSAN KENDALL CLAY SCHOLARSHIP FUND** — \$5,000. This fund shall be used for the scholarship given biennially in memory of Susan Kendall Clay (a member of Delta Gamma Sorority), mother of Catherine A. Clay, University of Nevada, Las Vegas-1Φ. This scholarship is for National Convention expenses for a member in good standing with high academic rating, and at least one year remaining in the Iota Phi chapter. (If there is no qualified candidate in Iota Phi chapter, a recipient may be selected from another collegiate chapter in Province XV-S). This fund was established in loving memory by her daughter, Catherine.

7. **LINCOLN, NEBRASKA ALUMNAE/GLADYS ENYEART GELWICK MEMORIAL SCHOLARSHIP FUND** — \$1,000. (to be increased to \$2,500) This scholarship, given annually to a Nebraska Wesleyan University-BT junior or senior, is by application and awarded to a collegian in good standing who exemplifies loyalty and support to the chapter. This fund was established by the Lincoln alumnae chapter with funds willed to the alumnae by Gladys Enyeart Gelwick.
8. **NANCY SOLOMON/ALPHA SIGMA MEMORIAL SCHOLARSHIP FUND** — \$1,000. (to be increased to \$2,500) This scholarship, given annually in memory of Nancy Solomon, Florida State-AΣ, is by application and awarded to a collegian in good

standing in Alpha Sigma chapter. This fund was established by the Florida State-AΣ chapter.

#### **GRANTS:**

- A. **HEARING HELP GRANTS:** Six grants were given to speech and hearing facilities in 1985-86 totaling \$2,025, and three grants in 1986-87 totaling \$985. These grants are given upon application to the FMF from alumnae chapters working with speech and hearing facilities. Amounts of grants depend upon interest earned on fund principal contributions received in the Hearing Help Fund.
- B. **DELTA ZETA SORORITY:** \$5,000 to be applied against expenses incurred in the publishing of educational materials (manuals, etc.)
- C. **VAUGHN FOUNDATION** of Tyler, Texas: \$1,500 grant for the summarizing of the federal and state laws protecting and/or assisting the deaf in the State of Texas. This grant was secured by Virginia Odle Voelker, University of Houston-ΔΘ, as a project for the newly chartered Tyler alumnae chapter. \$250 was designated for the House Ear Institute.
- D. **BETTER HEARING INSTITUTE:**
  1. \$3,000 grant for the publication of an edition of "We Overcame Hearing Loss" celebrity booklet. Sponsorship credit line read, "Printed through a grant from the Delta Zeta Foundation." (A copy was mailed to each chapter in early 1986.)
  2. \$22,000 grant to create, produce and distribute a BHI television Public Service Announcement starring Delta Zeta FLORENCE HENDERSON. This PSA has been viewed on more than 400 stations with a free air-time valuation exceeding \$2 million.

**SPECIAL GIFT:** \$75,000 life insurance policy on behalf of the Founders Memorial Foundation has been given anonymously. This most gracious and generous gift is from a non-Delta Zeta.

**LEVELS OF GIVING** were established to recognize those individuals who give graciously to support the endeavors of the Founders Memorial Foundation.

**GALLAUDET UNIVERSITY:** On August 4, 1986, President Ronald Reagan signed into law the Education of the Deaf Act, thereby bestowing university status upon Gallaudet. We as Delta Zetas share in the joy of this momentous achievement. The EDA also established a Federal Endowment Challenge Program at Gallaudet which provides \$1 million per year to match gifts of endowment to the University during the next five years.

To date our contributions to the Delta Zeta-Gallaudet Endowment Scholarship Fund this 1985-87 biennium have been \$11,811.66. This fund presently exceeds \$100,000. Six \$1,000 scholarships were given for the 1985-86 school year, and five \$1,000 scholarships for the 1986-87 school year.

**HOUSE EAR INSTITUTE:** This fund provides Delta Zeta's participation in research, training of surgeons, current developments and assistance to all ages and

types of hearing impairment. Our first general membership contribution this biennium was \$6,274. The Lamplighters of Southern California Flame Fantasy benefit gave contributions of \$12,993 in 1986, and \$13,329 in 1987.

The House Ear Institute is now in a capital campaign to build a new facility and \$19,603 of our 1985-87 contributions have been designated gift for Delta Zeta's participation in this new facility. A designated gift from the Delta Zeta Founders Memorial Foundation has not yet been determined. This would be a 3-4 year pledge.

**DELTA ZETA FOUNDERS MEMORIAL FOUNDATION TRIBUTE:** This rotating award was established by the Board of Trustees in January 1987, to recognize special service to Delta Zeta and the Founders Memorial Foundation through the giving of TIME, TALENT AND TREASURES. This award will be presented at the Board's discretion, and not necessarily on a regular basis. The first presentation, February 28, 1987, at the Flame Fantasy benefit was to the Lamplighters of Southern California.

**PANHELLENIC FOUNDATION CONFERENCE:** The Founders Memorial Foundation participates in the conference which exists to promote a greater awareness of common issues and concerns that face Panhellenic Foundations in today's world. The goal of the conference is to promote education, sharing and learning on a non-competitive basis. Programs include tax law and accounting concerns pertinent to non-profit foundation, fund raising, public relations, and "hot" topics concerning Panhellenic Foundations today.

**COUNCIL FOR BETTER HEARING AND SPEECH MONTH:** Membership on this Council increases Delta Zeta's participation in the educational programs to

increase awareness about hearing and speech problems, to improve understanding of others who suffer from them and to learn about current research during MAY — Better Hearing and Speech Month. As a sponsor Delta Zeta Sorority and Foundation is listed in nationwide publicity materials.

**NATIONAL INTERFRATERNITY CONFERENCE, INC., FOUNDATIONS SECTION:** Membership provides educational opportunities and information sharing services.

**McADAMS HOUSING MATCHING CHALLENGE:** Norma Clark McAdams, Oregon State-Chi, gave a \$5,000 challenge grant at the 1985 National Convention to be matched by \$20,000 in contributions from Delta Zeta members and chapters by the 1987 National Convention. This fund will be used for assistance in collegiate housing needs, i.e., new houses, recolonization housing, enlargement of existing houses, remodeling or redecorating existing houses or suites.

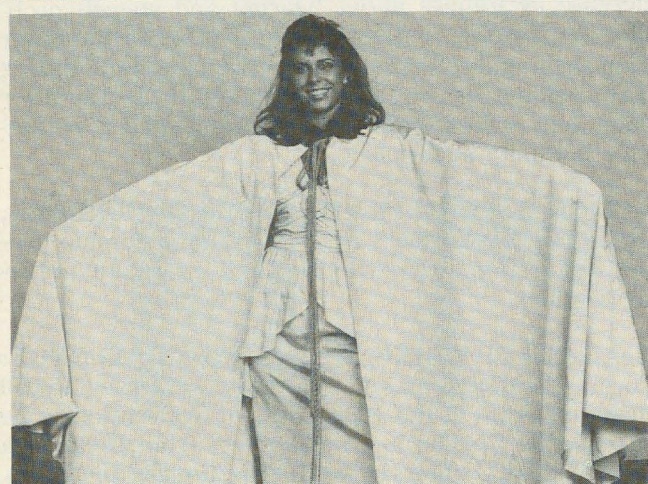


# Convention Memories

Delta Zeta conventions are wonderful, exciting times. And to those who attend them, each convention has its highlights, many of which were featured in the Convention Memories style show in the Museum luncheon program at Innisbrook.

None of us now living attended those very early conventions. In fact, the 1907 one in Dayton and the 1908 in Oxford were actually reunions for Alpha members. But in 1910 a real national convention was held in Indianapolis and according to history, a Lawn Party was held at the YWCA and later a Panhellenic tea at the home of the Misses Railsback.

In 1912, the officers, in early pictures, cavorted in the waters of Winona Lake. In 1916 a tea was held in the Governor's mansion in Lincoln, Nebraska. In the accompanying photographs you can see the gowns worn at the various conventions, modeled by girls from Alabama, Georgia, Kentucky, Louisiana, Iowa, Nebraska, Ohio, Illinois, Oklahoma, Texas, Colorado and Florida.

This writer attended her first convention as a collegian in 1928, and the outfits from then on were actually worn at the various conventions. Luckily, some of us never throw anything away, especially clothes that bring back golden memories.

Naturally at the two Pasadena conventions in 1938 and 1960, we had our own version of the famous Rose Parade. At the early one, chapters made miniature floats covered with real flowers furnished by the hotel. Later, at the Province Pride luncheon, each group portrayed their province with tableaux posed in front of the speakers' table. Ohio literally took the cake with their red and white cheerleaders.

Highlight of both conventions was the beautiful Hawaiian dinner held around the pool. In 1966 in the Bahamas we all wore muu-muus and such at an outdoor buffet dinner. Gwen McKeeman even saved her colorful dress which was modeled by Cindy Winslow.

Chicago hosted three conventions, and in 1958, a contest was held to elect a Convention Queen. Newly elected President Helen Nolop crowned blonde Mertie Cate Barnes from Sigma chapter at the final luncheon. The robes she wore were modeled this time by Sigma's current president, Amy Viso.

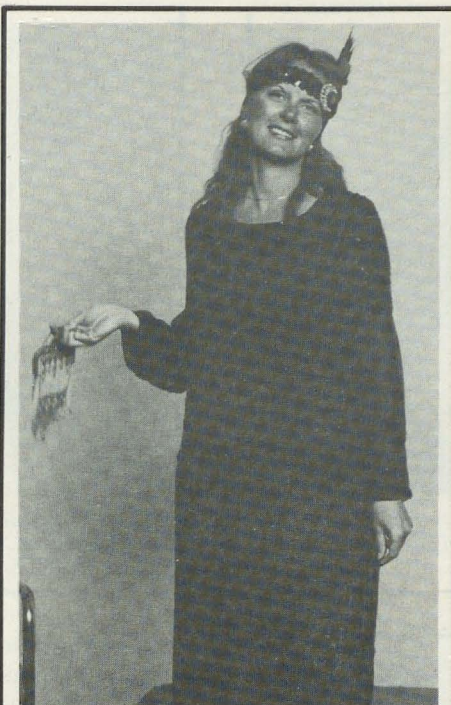
A fun thing at this convention was the contest to find your twin. Name tags had numbers and you had to search for your twin, and could immediately come together to claim your prize. At this convention Gamma Nu chapter at Eastern Illinois received the Council award, so it was appropriate to have Kim and Kerri Robbins, real-life twins from Gamma Nu in our show.

We convened in St. Louis at the Chase Hotel in years 1954 and 1968. In those days it was a tradition to have

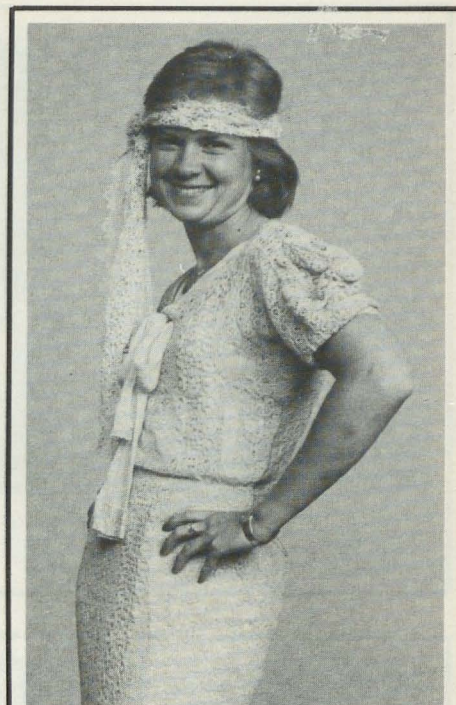




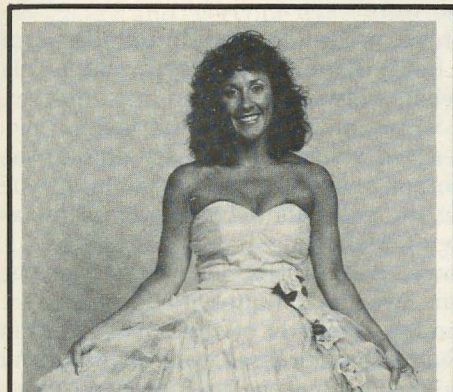

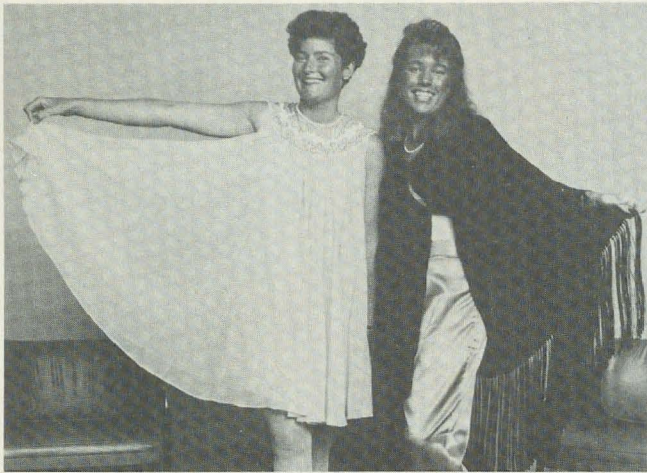

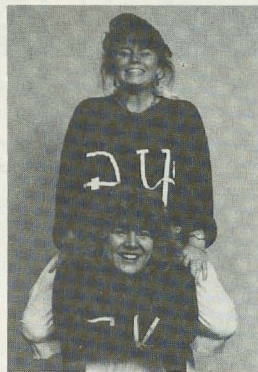

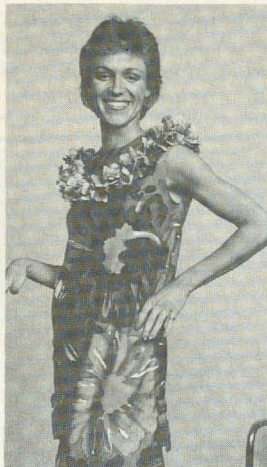

talks representing Council, Province Directors, and Alumnae and Collegiate presidents. In 1954, the president from the Louisville chapter, Carol Sharpe, had to follow such luminaries as Julia Bishop Coleman and Gertrude Houk Fariss, and she saved her gown of shaded net which Jennifer Plenge, presently Kentucky Province Director, wore.

One of the fun things at the Pups and Hounds dinner in 1968 directed by Katie Blanche Stallworth and Myrtle Hinkly was the debate between mini and maxi dresses, which like today were competing for the fashion picture. Carol again saved a very mini dressy culotte she purchased just before convention in St. Louis. A blue chiffon, beaded at the yoke almost stole this show as modeled by Shawn O'Halloran.

Probably the most beautiful banquet ever was the Oklahoma Indian Awards banquet. Programs were Indian teepees, and the shields of the various Indian tribes with their feather headdresses were displayed. All of the Oklahoma delegates were in Indian costume. Gwen McKeeman and Marvona Tavlin couldn't bear to do away with their costumes. Gwen was the toast-mistress and Marvona then a college president.

Baseball hero Stan Musial was swamped by ΔZ fans when he arrived to pick up his wife Lillian who was the convention initiate. The scoreboard at the stadium lit up that week with a welcome to Delta Zeta.

At the 1970 Phoenix opening banquet, a national vice-president wore a daring long white chiffon outfit with pants, only to be greeted by a collegian from Iowa in one of apricot chiffon. We chuckled at the later NPC meeting when the chairman appeared in the same outfit but in brown chiffon.

To refresh our memories of what happened at this convention Lampkin staff Diane Skelton and Beth Moore painted a jacket for this Editor with all of the highlights. (At the next convention they added a hat also depicting the highlights happenings in Palm Beach.) I am sure in years to come, no one present last summer will forget the rose trimmed tennis shoes the Lampkin

staff came up with. Of such are memories made.

We returned to Arizona in 1985 with an outdoor ranch type dinner, and everyone wore rodeo dresses and skirts and danced the Cotton Eye Joe. Our Texas darlings in the show looked more like Rodeo Drive than ranch type rodeos.

Florida in the summer is a popular convention place and this was our fourth trip to the sunshine state. Norma Andrisek came to her first convention in Miami in 1956. Psi chapter came from Franklin, Indiana in its entirety to sing all through convention. They probably sang all the way down and back on their chartered bus.

It was to the Breakers in Palm Beach in 1973. Beverly Burnsed was in charge of the Fun dinner and she made it a circus event with decorations and favors from Ringling Bros circuses which wintered in Florida. Everyone was told after they arrived to design a costume appropriate to the occasion, and the outfits were wondrous. Bev was the ringmaster, Gwen the lion tamer, me the fat lady, and Jane Thompson covered her bathing suit with balloons.

Everyone remembers rain and the problems it produced. In Swampscott in 1948 delegates had a boat trip up to Salem and back in very rough weather, culminated with a lobster feast on the beach. It rained, and it poured, and some even crawled under tables to finish their feast.

And it rained just before the Awards banquet at the Doral in 1979. Chairman Carolyn Gullatt in a stunning pink chiffon got there early to see to the decorations, and then she waited, and waited, for everyone to arrive. Since we were housed around the grounds, no one wanted to drench their lovely formals, and the dinner was served an hour late.

Delegates were told to wear a tee shirt and bring one to exchange around the pool another evening. The Findlay, Ohio, alums presented me with one of theirs which read "ΔΖ, It improves with Age."

Our parade of convention memories ended as it began, with early twentieth century gowns, but these three were worn by Council members and their escorts at the Diamond Jubilee convention in Columbus, Ohio. Mary Lou Barth sent two gowns from her family treasures, and Marianne McKeeman wore hers to escort her mother.

Some of the luncheon decorations were also saved from previous conventions. The program read "Butterflies, like memories, are beautiful and fragile."

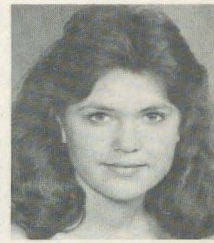

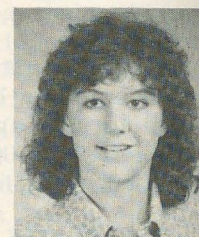

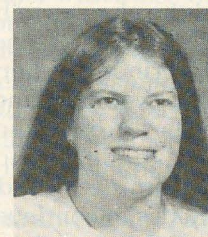

# He was a 'Born Leader'

To the world of education, Dr. John Richard Andrisek will be remembered as a leader, a teacher, a thorough problem solver with a goal — he always had a mission. To Delta Zetas, he will be remembered as a friend — and as our Norma's husband.

A former Marine, Dick Andrisek successfully guided the Berea (Ohio) school system through a financial minefield, earning it a state-wide reputation for excellence. Superintendent Andrisek died on August 6 of a massive blood clot in his lungs.

Dick was an intensely private man with a rather austere public demeanor; but he was a "born leader" according to his friends and associates. One of his golfing buddies was quoted in the *Berea News Sun* as saying, "He was quiet in the sense that he was not obtrusive or pushy, but he ran deep, really deep."

Dick was also an enthusiastic jogger, regularly running with a group that included school board member Leroy McCreary. McCreary said: "I was one of his running buddies. He would just turn up at my house and we would take off."

"I am very hurt that Dick did not have the opportunity to complete his

program with the board and then finally have the chance to do what he wanted to do so badly. (Dick had planned to resume his teaching career in the area of educational administration at John Carroll University in January.) He was a real class act."

Dick Andrisek died four months short of his retirement as Superintendent of the Berea Schools. He left behind a solvent school system with a national reputation for excellence — no small feat. Appointed superintendent of schools in 1973 following three years as assistant superintendent, Dick instituted a number of innovative policies in the Berea system that were subsequently adopted by school administrators throughout the state and, in some instances, across the country.

In 1986 Berea High School was recognized for excellence by the U.S. Department of Education — a source of considerable pride to Dick.

A graduate of Baldwin-Wallace College, Wesleyan University, with a Ph.D. in Educational Administration from Case Western Reserve, he served as consultant to seven school districts, from Kenai, Alaska, to North Royalton.

He was the author of several publications, including one on how to manage a strike and one on five year planning. Dick also taught graduate courses at Cleveland State University.

He was named Ohio PTA Educator of the Year in 1977 and was given the Baldwin-Wallace Alumni Merit Award in 1986.

Dick was a member of the American and Buckeye Association of School Administrators, the Suburban School Superintendents, the Greater Cleveland School Superintendents, which he served as president in 1983 and Phi Delta Kappa.

His friend Neal Hesche, called back from retirement as interim superintendent in Berea, talked of Dick's family life. "He was a person who had to climb to the top of every mountain peak in Rocky Mountain National Park just to say he and Norma did it."

Hesche continued, "I'll remember the man whose real pride in Norma's vocation allowed himself to overcome a small chauvinistic tendency and be introduced as 'Norma's husband.'"

He remembered Dick as a proud father, concerned about his children; and as a proud grandfather, especially at football games when he was no more than seated and he had to answer his grandchild's request for "popcorn, grandpa." He was so proud as he sat in son Rick's race car on a victory lap. And, Hesche continued, "he was a loving and devoted husband."

"But most of all," Hesche said, "I'll remember his telling me, 'Neal don't tell me your problems, just get the job done.' Then, he'd smile and walk away. 'Because of Dick, we'll all walk away from here stronger and better people for having known him. We thank God for allowing us to share in Dick's life.'"

Dick Andrisek is survived by his wife Norma, son Rick, daughter Susan and three grandchildren.

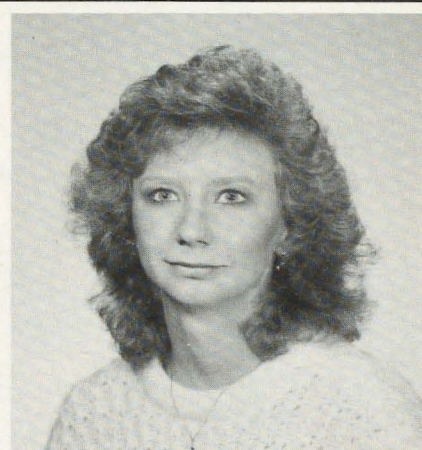

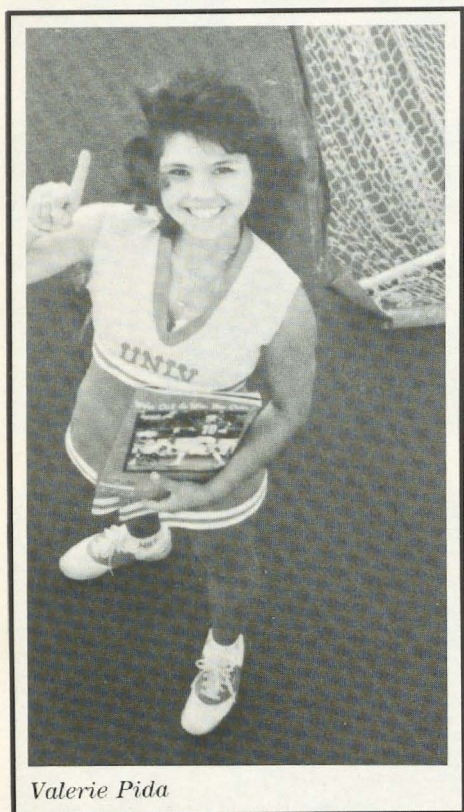

# VALERIE: A True Delta Zeta

During UNLV's climb to the Final Four Basketball Championships last March and April, Las Vegas newspapers and television stations overflowed with the news of the Runnin' Rebels success. Then they discovered a special human interest story: one of the UNLV cheerleaders was suffering from cancer and needed an expensive bone marrow transplant or, as she stated during a television interview, she would die.

UNLV cheerleader Valerie Pida was 19-years-old then and fighting off Hodgkins Disease for the third time in seven years.

After the publicity, thousands of Las Vegans and people across the country came to her aid and donated money to help pay for her medical expenses. The bone marrow transplant was performed last April, and Valerie is now recovering at home.

To Las Vegans and members of her sorority, she is a celebrity and "VALERIE" is a household name synonymous with courage and strength. Through all the pain, drama, and publicity, Valerie has maintained her charm and modesty and still makes complete strangers feel as if she is their very good friend.

I first met Valerie on the night of her Delta Zeta initiation last spring. I wanted to meet the girl the entire city was talking about; she was everything I expected and more. Not only was she beautiful, but probably the nicest person I ever met.

Valerie had pledged the Iota Phi chapter of Delta Zeta during the 1986 fall semester. She was to be initiated with her pledge class, but she found that the cancer had grown back and had to drop her classes. Valerie did not tell many people about this and her friends kept her secret.

It was not until the media focused on Valerie that the chapter understood the truth. They quickly planned a special initiation before Valerie cheered on the Rebels at the Final Four and then entered the City of Hope Hospital in Duarte, Calif.

While the chapter was preparing for initiation, I sat with Valerie and we talked. She was excited about the initiation and told me that if she had daughters, she wanted them to join Delta Zeta.

I have talked with Valerie on several occasions since that night and each time I feel so very special because I know such a remarkable person. She said many people tell her she is special and that she brings out the best in them.

"If I was an inspiration that brought out the good in some people, then they are the ones that are special. I didn't give it to them, they always had it," she said.

Valerie laughs at many experiences in her life which most people would find sad or bitter. She sees good in everyone and everything, and her sincerity and innocence endear her to friends, family, and even a city of strangers.

Despite the suffering her illness has incurred on her and her family, Valerie talks about her cancer as if it was a fact of life, like going to the dentist for yearly check-ups. She has strived for normalcy and order in a life turned upside-down every few years by cancer.

The first signs of cancer appeared when she was 12 years old and had discovered a lump on her neck. Her parents took her to a hospital, but the physician told her it was nothing to worry about and to apply a heating pad.

Valerie found more lumps and went back to the hospital several times over the course of a year only to be told that she was healthy. She began to ignore the growths even though they had increased to 10 and were spread across her neck and under her arms. So when she needed a physical to play volleyball for her junior high school, Valerie was surprised by the physician's response to her lumps.

This time a different physician checked Valerie and immediately suggested a biopsy. The operation determined that Valerie did indeed have cancer and she underwent treatment at once.

Valerie requested that the hospital not be named to save them from embarrassment, and she never mentioned the fact that, maybe if they had discovered the cancer a year earlier, it would not have become so severe.

But that's not Valerie's style. In fact, she laughs about her junior high school days when she became a cancer victim and a teenager simultaneously.

"When I got it, I just fit it into my schedule. It became another activity. I never thought about it in a negative way, I just dealt with it. Thinking back it is pretty funny because I kept a 4.0 grade point average."

She went into remission in junior high and the hair she had lost during chemotherapy grew back. Then while attending high school, she again suffered from the lymphatic cancer. Despite her baldness, pain and chemotherapy, Valerie spent her high



school years as a cheerleader just as she had done in junior high.

The cancer went into remission again and her family relaxed until Valerie's sophomore year at UNLV when they found the cancer had grown back. This time, she was told that she needed a bone marrow transplant or she would die.

Valerie knew she would survive.

"I was told I would die without the operation, but I knew I would never die from the disease. I've always known inside that this would be the most difficult thing I've ever been through in my life, but I would come through," she said about the cancer and the bone marrow transplant.

Her steady belief in herself helped her through the pain and fatigue she experienced before the bone marrow transplant, and she cheered on the Runnin' Rebels at the Final Four just days before she entered the City of Hope Hospital.

"I was sick during the game, but I didn't let it show. I was there to cheer-not be sick," she said about her job as a cheerleader which she has always taken very seriously.

She was greatly disappointed by the Rebels loss, and she cried at the end of the game. She cheered up after one of the players put his arm around her and said the loss wasn't so bad because the players had realized that there were more important things in life than the game.

After the excitement of cheering in front of thousands, Valerie had to deal with the reality of her situation.

Her third, and final, battle with cancer gave the Pida family a more serious responsibility — not only would one of them have to offer their love and support, but also a part of themselves.

Her brother John, who was in the Air Force and stationed overseas, was transferred closer to home. Until John returned from Germany, her sister Teresa had been slated to donate the bone marrow since hers was a closer match than Valerie's parents and youngest brother, Michael's.

John was ultimately selected as the marrow donor. Teresa was relieved, not because she feared the operation, but because she dreaded the idea that Valerie might not accept her marrow.

"I don't think Teresa could have taken it emotionally if I had rejected

her marrow," Valerie said.

The actual bone marrow transplant was easy. It was the medication and treatment before and after the operation that was difficult to handle.

She was put on a special anti-bacterial diet and placed in isolation after the transfusion to protect her from any infection. Her white blood cell count went to zero, and she was extremely weak. Even then she said she did not lose hope, but she was not very enthusiastic either.

"I was just sick; I was just there."

Those first few weeks Valerie lay in bed too weak to even move. She concentrated on getting well for four months after the transplant and she spent much of her time in a special recuperation apartment on the City of Hope grounds. She was visited by friends and family, and she formed new friendships with other patients and the medical staff.

When the first biopsy showed that Valerie's body had not rejected the new marrow, words did not have to be spoken — Valerie understood the good news by her mother's smile.

Since her determined recovery, Valerie is taking things day by day. She adds, however, she has always lived life that way.

"I appreciate little things like . . . breathing," she said with a laugh. "I am grateful I am not blind or deaf. I have heard friends complain about stupid things and I tell them they should be happy that they are alive, that they can walk, because if you

think about it, there will always be someone worse off than you are, and you should be thankful that things are not worse."

Valerie has already returned to school, Delta Zeta, and cheerleading. Because she must guard against infection, she often wears a surgeon's mask in public, and she has received some strange glances.

While walking through the student union, two young men said to each other, "she's really taking this AIDS scare seriously."

Valerie just laughs as usual.

The chapter has warmly welcomed her back. She can only attend certain small functions at this point, but she has been building up endurance for additional events.

Recently, the chapter nominated Valerie as their Homecoming Queen candidate and she modestly, but happily, accepted their honor.

I am proud of Valerie and of the chapter. I know that all the girls in Iota Phi are very special, but when Valerie is around, they are unanimously so. She does bring out the best in everyone and she exemplifies what Delta Zeta means: strength, courage, kindness, sincerity, pride, spirit, and most of all, love.

I know I speak for the entire chapter when I say, "thank you Valerie for being my Delta Zeta sister."

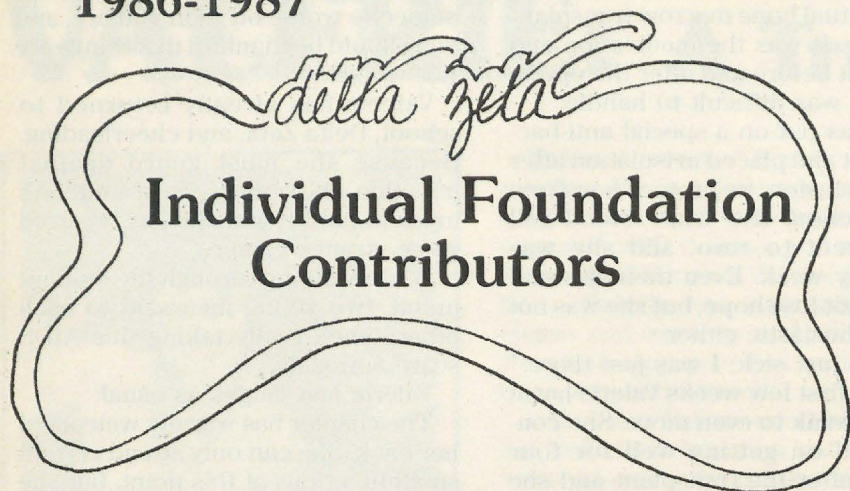

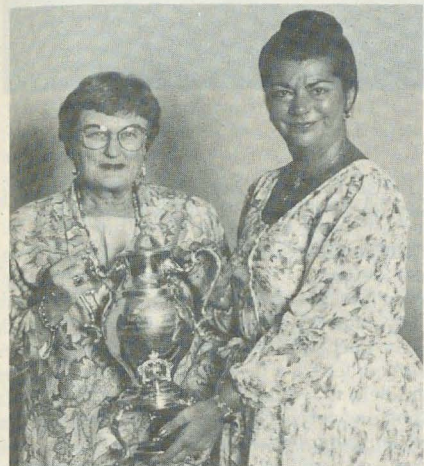

**Tampa, Beta Delta** — Delta Zeta boasts the



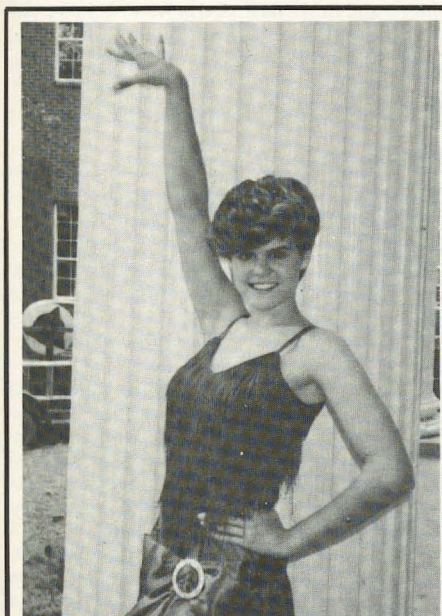

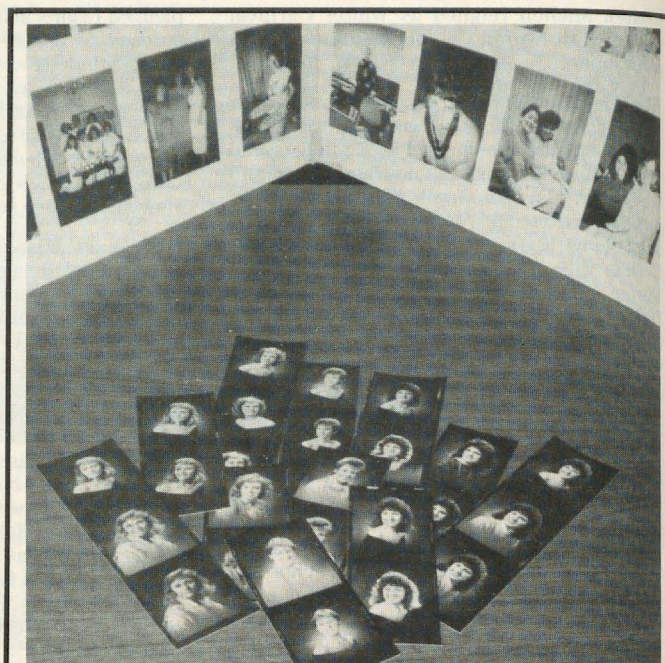

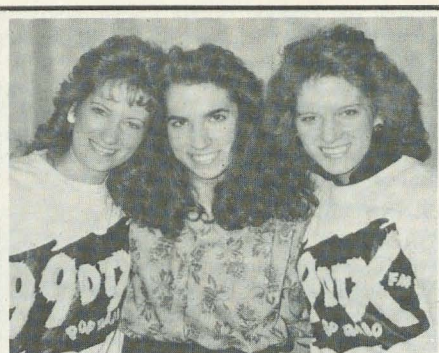

Golden Girls' practices, Natalie said, is when everyone talks at once. It is hard to understand because she can lip-read only one person at a time. But, she continued, "they're all very patient. They understand how I feel, and I understand how they feel."

As for future plans, she wants to travel throughout the world and work as a photographer. "And I want to teach deaf children to dance," she said.

The second rather special Delta Zeta is Valerie Pida, University of Nevada/Las Vegas-IΦ chapter. Valerie is the cheerleader publicized by her college's basketball team when they went to the NCAA semi-finals last

March. The reason? Valerie has been battling cancer.

I had intended to tell you this story, but her CCD Lisa Story has done a fantastic job, and so her story is elsewhere in this issue. Another rather special Delta Zeta is Valerie.

Some chapter LAMP editors do such exceptional jobs with reporting, pictures, meeting deadlines that I have decided to recognize two for this quarter. Gold stars to Donna Falcone, Texas A & M-ΛΞ chapter and Lori Hebel, University of Louisville-BΓ chapter. Are there others out there in ΔZ-land?

The LAMP does not often feature stories of individual undergraduates. With some 7,000 members on the 150+ campuses, you can see why. I do want to tell you about two special young women, though.

How does she dance? Natalie listens to the bass beat (with the help of a hearing aid) of the music and counts the steps as she goes along. This way she is able to blend in with the Golden Girls as they perform their dance routines. In fact, she was already on the squad before the other dancers noticed that she is deaf.

A note from Peggy Haskell Benjamin, Nebraska-Z mentioned an item she thought would interest Delta Zetas. She had been reading letters her grandfather, Enoch Haskell of Oxford, Ohio, had written to her parents in Nebraska. Dated November 20, 1884, one letter read in part: "George Adams is building a fine house on the old University (Miami) lot and Frank McCord's mother is building one where the old school Presbyterian Church stood . . ." Many of you may recognize the McCord house as being our National Headquarters and Historical Museum.

The following letter I find most interesting. Mailed from Reutlingen, West Germany, it reads:

"Dear Delta Zeta Sisters,

"Thank you so much for sending me that document saying I am awarded the Order of the Golden Rose by the National Council for having been a Delta Zeta for 50 years! It gives me deep feelings of joy and pride to have been honored in that way. I will hold the document in high esteem and keep it for my grandchildren. The year of 1935/36, which I was allowed to spend at De Pauw University and at the Delta Zeta house, was very important and has influenced my life since. It was indeed a long voyage then from Hamburg to New York — and it was a completely different and unheard-of world which I entered, a nineteen-year-old German girl, fascinating, impressive and even a bit threatening at times. The friendly reception and kind responsiveness of the girls at the Delta Zeta house helped me to find my way, though.

"It is a great thing that at that time in America I found friends for a whole lifetime. I am still in regular correspondence with Alice

Edelmaier Taglauer in Maitland, Fl., with her sister Esther Trautwein in Fort Thomas, Ky., and with the husband of my late friend Margaret Gulmeyer Walter in Detroit.

"'Belonging' to the Delta Zeta sorority has always filled me with amazement and gratitude. I still possess my Delta Zeta pin — which is quite a miracle, as my parents' house at Stuttgart was completely destroyed in 1944. What was more important to me, however, were the proofs of loyalty and human sympathy I got from my American friends after the war. The open-mindedness, generosity and the royal hospitality I experienced in your country as a young girl, still makes me take America's part today as well as then. My family has always had a liking for the New World (although my husband is a classical philologist); both of my children were given scholarships by De Pauw. Many guests from across the ocean have come to our house; only last week Dr. G.H. Grueninger was with us, my Foreign Student Adviser at De Pauw fifty years ago.

"Much time has passed since my initiation in 1936, but memories of 'the rose and the green' have always been alive — and they are now refreshed and strengthened by the privilege of the Golden Rose Order. Let me once again thank you most sincerely for this proof of my belong-

ing to you.

With cordial greetings to all Delta Zeta sisters.

Yours, Ilse Woessner Schmid"

And several times I've mentioned that I should tell you about a very special group who has been together for more than 30 years . . . and isn't that what Delta Zeta is all about? Meet my "Junior" bridge group from Tulsa, Oklahoma. My sisters . . . my friends!

Delta Zeta Field Representatives — who are these well dressed, enthusiastic, luggage-lugging travelers who live, eat, and breathe Delta Zeta 24 hours a day?

Contrary to popular belief, they're not wonder women, probation officers, miracle workers or spies hired by a network of mothers to check up on their daughters. Rather they are a group of caring, fun-loving college graduates who are dedicated to the ideals of Delta Zeta.

These "Vast Traveling Queens" as they were traditionally dubbed during fall training, were selected in the spring over numerous field representative applicants, each one bringing to Delta Zeta her particular talents and skills.

These fielders are a close-knit group who rely on each other, Carolyn Gullatt their fearless leader, and the services of Ma Bell for moral support, ideas, and occasionally for maintenance of their sanity while on the road.

Field representatives complete two weeks of training every August in Oxford and literally convert the second floor of National Headquarters into a sorority house. The 1987 team of field representatives has several unique characteristics. This touring troupe of 11 is the largest field staff in Delta Zeta history and is the largest staff of all 26 national sororities. Seven of the 11 fielders are traveling for their second year, the largest returning number, and five from this group are Grace Mason Lundy Award winners.

Fielders Barb Poremba and Kim Saari chose to describe themselves in this way:

A Delta Zeta field representative is — having to teach a chapter a song and not being able to carry a tune. — counting the number of chapters you've visited by the number of

sweat-shirts you own.

- a first step to becoming an active alumna.
- starting out with a boyfriend/fiancee and ending up single.
- trying to persuade the skycab to check four pieces of luggage.
- a semester of marathon rushes.
- meeting more Delta Zeta sisters than you ever dreamed existed.
- being underpaid, overworked, and loving every minute of it!
- like "totally rad!"

Let's meet the 1987 Delta Zeta Field Representatives.

**Lisa Albright** — "It's fun and it's exciting!" was Lisa's quote when asked about traveling for Delta Zeta. She is a graduate of Stephen F. Austin University where she was Junior Homecoming Duchess, a cheerleader, rush chairman and president of her chapter. She is on long-term assignment at Oklahoma State University where she is enjoying the success of Delta Zeta's new colony.



**Kathi Bray** — Kathi graduated from Central State University in Oklahoma where she was recording secretary, rush chairman, and president of her chapter. She was National President of DECA, Outstanding Greek Woman of the Year, and a Grace Mason Lundy and Florence Hood Miner Awards winner. Kathi is supervising the colony at DePauw and her comment is: "always believe in love, life and yourself to find the good in all things."

**Lee Ann De Reus** — When asked what she liked about being a field representative Lee Ann replied, "I get to play Delta Zeta, travel, I don't have to go to class, and I get paid to do it! It just doesn't get any better than that!" Lee Ann majored in political science and Delta Zeta at Iowa State University and is still not sure what she wants to be when she grows up. She was treasurer and president of her chapter, held several positions on campus and was a Grace Mason Lundy Award recipient.

**Sheila Judge** — Sheila graduated from the University of New Orleans where she was Student Body president, Panhellenic president, Delta Zeta's pledge educator and rush chairman, and a recipient of the Edgar Eburks Leadership Award. She is studying for her GRE and will pursue graduate work in student affairs. Sheila's philosophy on life: "Live each day one crisis at a time."

**Dawn Levreau** - Dawn has this to say about being a field representative, "I have certainly learned the true meaning of independence and responsibility and I thank Delta Zeta for giving me the opportunity to find those qualities and more within myself." about Delta Zeta, "A man's real possession is his memory. In nothing else is he rich, in nothing else is he poor." To which Kathy added, "My richest memories are in Delta Zeta." A history major at the University of Washington, Kathy plans to go back to school after traveling for Delta Zeta, to get a degree in finance and then attend law school. She was enrichment chairman, pledge educator, and president of her chapter and named Outstanding Collegian of her province.

If you ask the field representatives why they decided to travel, some will say they wanted a break before starting graduate school. Others chose traveling because they're still not sure what they want to be when they grow up. But all will tell you that being a field representative is their way of giving back to Delta Zeta for all the years of joy it has given them.

The LaVonne M. Heghinian Scholarships were announced for the first time at convention. Totaling \$17,500, these scholarships are the largest given by Delta Zeta.
